PROPOSED FARM OPERATIONS EASEMENT

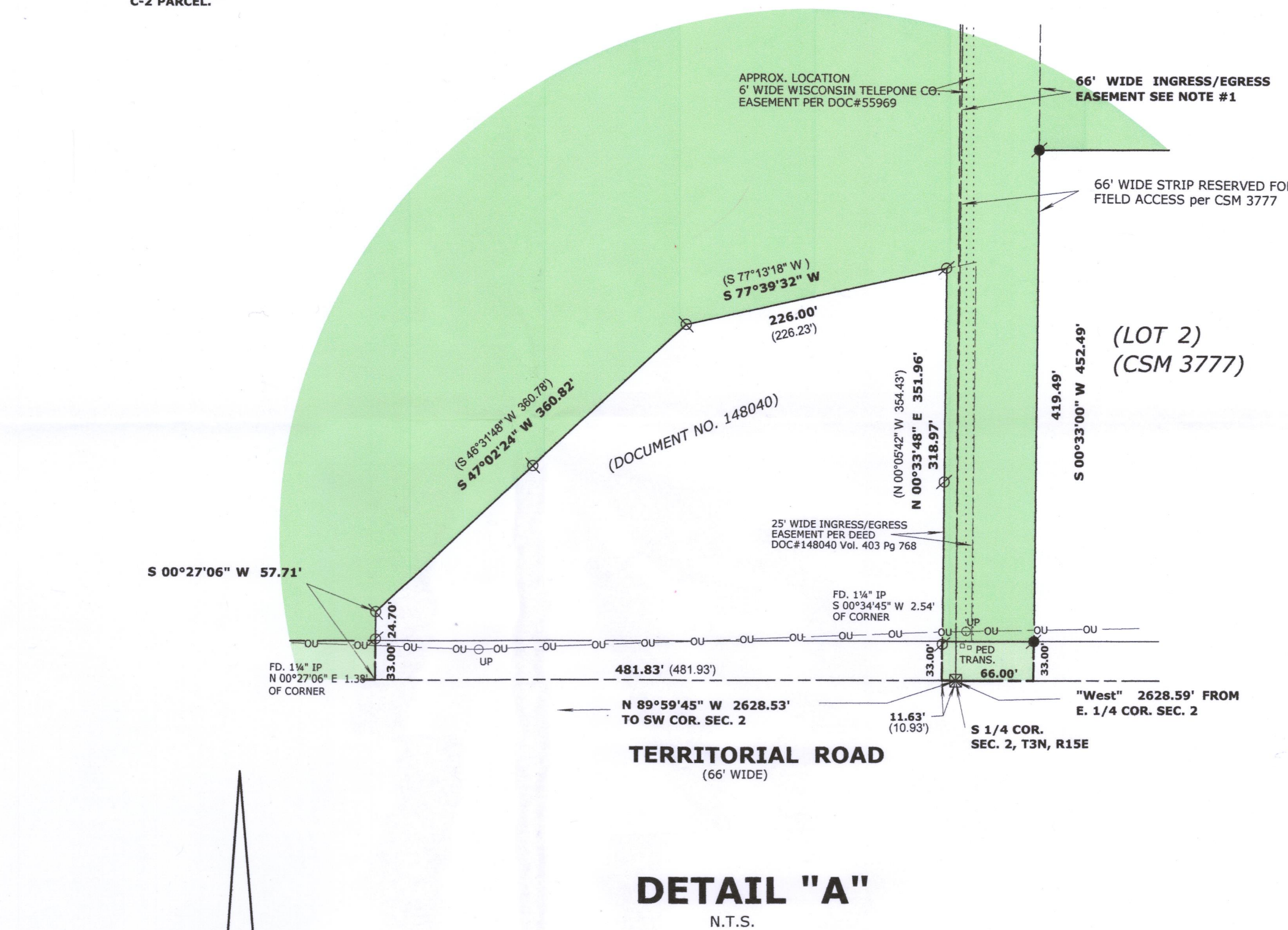
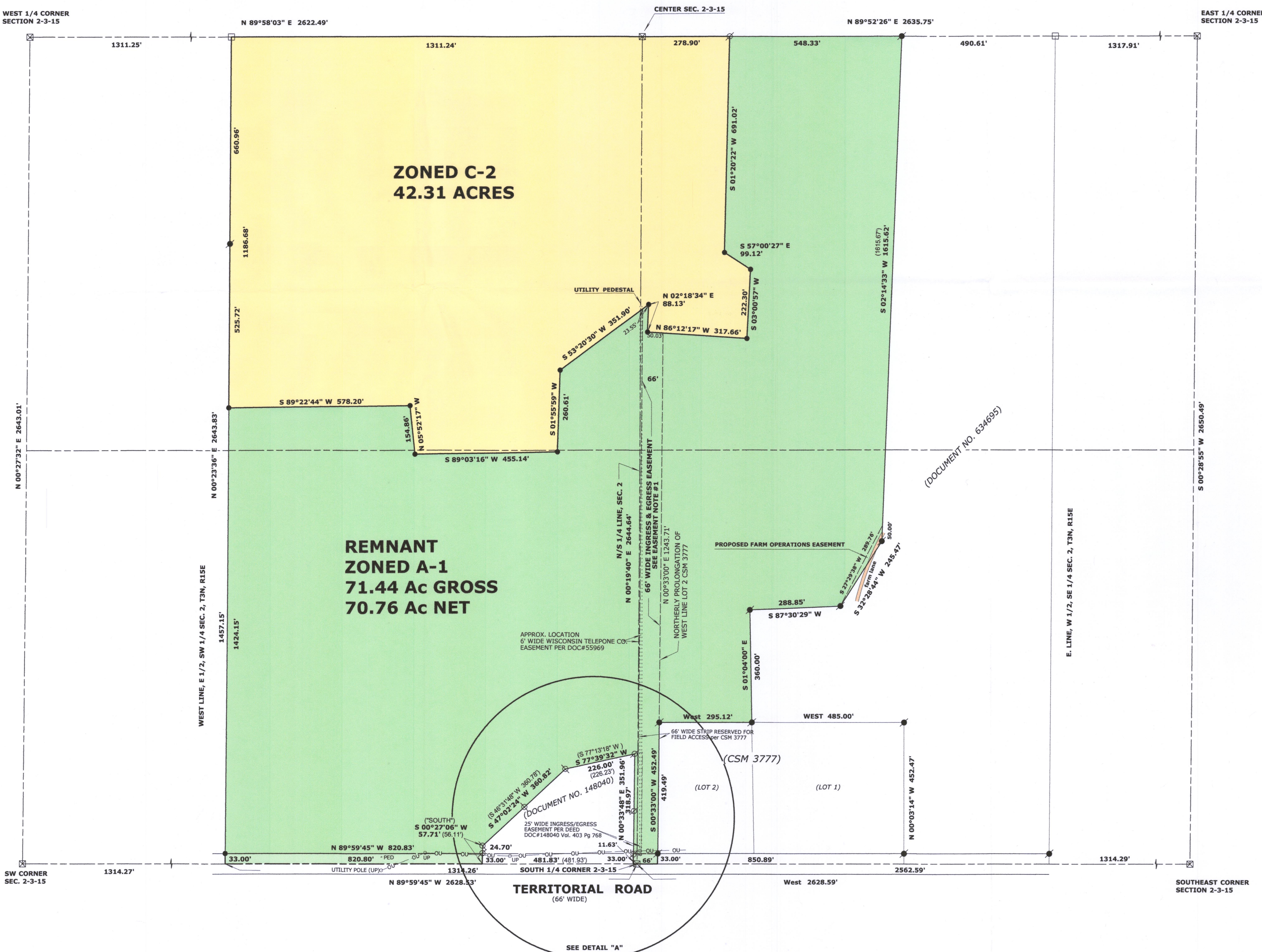



THE INGRESS/EGRESS EASEMENT SHOWN HEREON IS TO BE CREATED FOR THE USE AND BENEFIT OF THE OWNER(S) (PRESENT AND FUTURE) OF THE PARCEL HEREON REFERRED TO AS C-2. THE EAST LINE OF SAID EASEMENT SHALL BE THE WEST LINE OF LOT 2, CERTIFIED SURVEY MAP NO. 3777 AND IT'S NORTHERLY PROLONGATION. THE WEST LINE OF SAID EASEMENT SHALL BE A LINE PARALLEL TO AND 66' DISTANCE OF MEASURED AT RIGHT ANGLES) SAID EAST LINE. BOTH SIDELINES OF SAID EASEMENT SHALL BE EXTENDED OR SHORTENED SO AS TO TERMINATE ON THE SOUTH, AT THE NORTH LINE OF TERRITORIAL ROAD, AND ON THE NORTH BY THE SOUTHERLY LINE OF THE ABOVE MENTIONED C-2 PARCEL.
