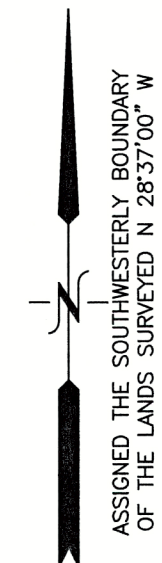

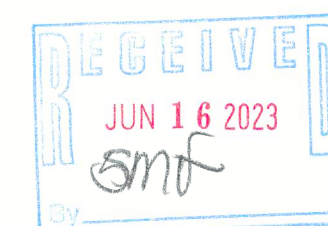
LAKE LORRAINE

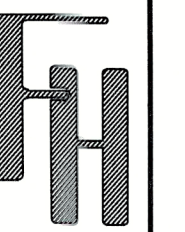
