W, ALONG SAID CENTERLINE, 475.00 FEET TO A POINT; THENCE S 89DEG  
14MIN 44SEC W, 460.00 FEET TO A POINT; THENCE S 00DEG 45MIN 16SEC  
E, 475.00 FEET TO A POINT; THENCE N 89DEG 14MIN 44SEC E, ALONG  
SAID CENTERLINE 460.00 FEET TO THE POINT OF BEGINNING.

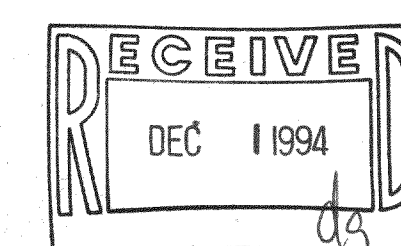
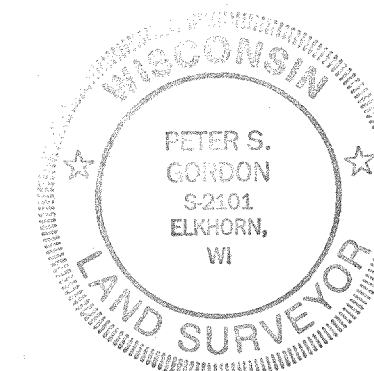

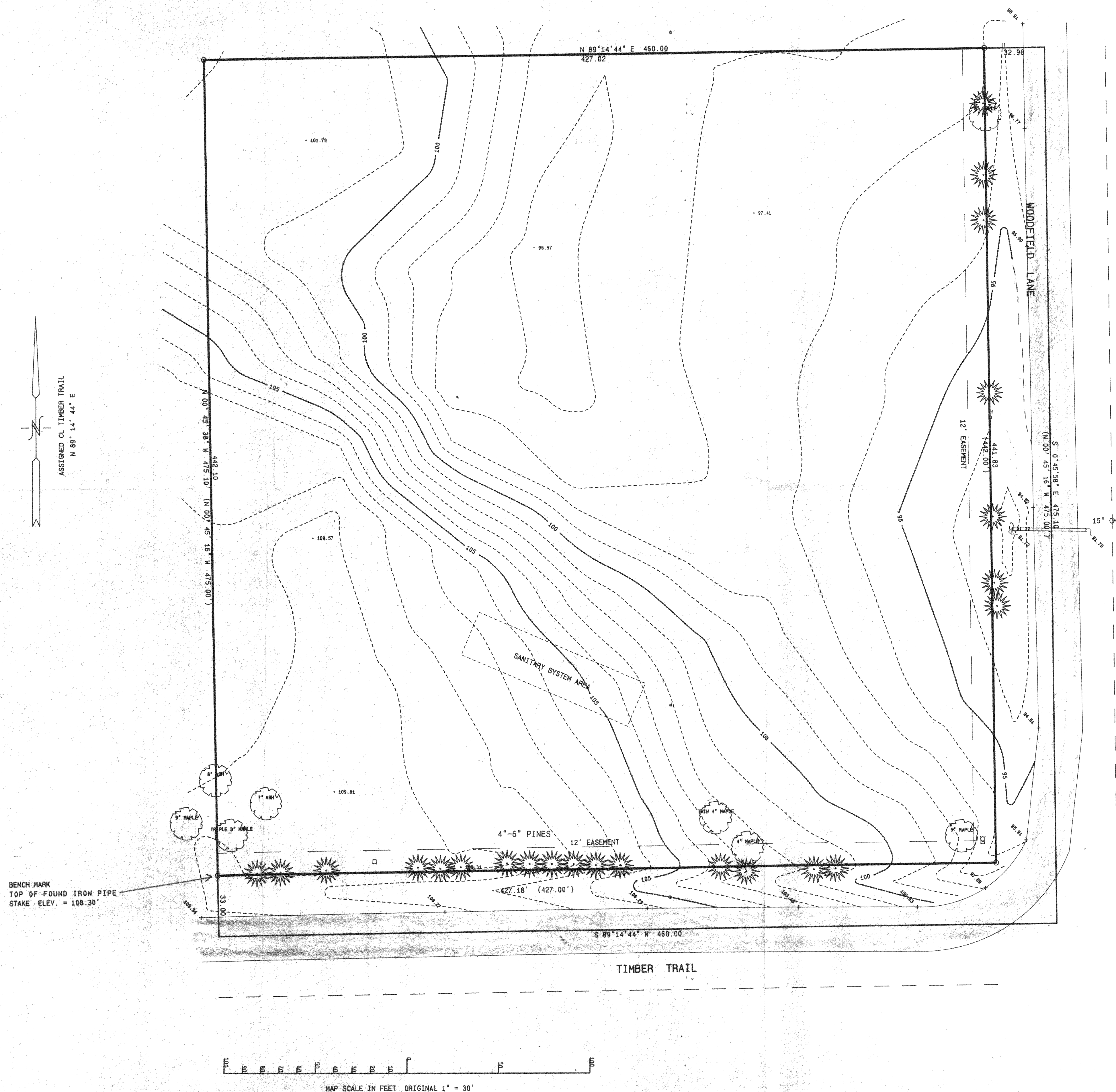
