A PORTION OF LOTS 21 AND 22, BLOCK 20 OF SKANSEN SWEDISH TRIBUNE-NEWS SUBDIVISION, LOCATED IN PART OF THE SOUTHWEST 1/4 OF SECTION 9, TOWN 3 NORTH, RANGE 15 EAST, RICHMOND TOWNSHIP, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:
COMMENCE AT THE NORTHWEST CORNER OF SAID BLOCK 20; THENCE S 00°01'49" E 159.92 FEET ALONG THE WEST LINE OF SAID BLOCK 20 TO THE SOUTHWEST CORNER OF LOT 22; THENCE S 89°53'54" E 64.82 FEET ALONG THE SOUTH LINE OF SAID LOT 22 TO THE POINT OF BEGINNING; THENCE N 00°01'42" E 60.04 FEET TO THE NORTH LINE OF SAID LOT 21 AT THE SOUTHWEST CORNER OF LOT 18; THENCE S 89°57'19" E 30.05 ALONG SAID NORTH LINE TO THE NORTHEAST CORNER OF SAID LOT 21; THENCE S 00°04'35" W 60.07 FEET ALONG THE EAST LINE OF SAID LOTS 21 AND 22 TO THE SOUTHEAST CORNER OF SAID LOT 22; THENCE N 89°53'54" W 29.92 FEET TO THE POINT OF BEGINNING, AND CONTAINING 1,801 SQUARE FEET OR 0.041 ACRE(S) OF LAND, MORE OR LESS.

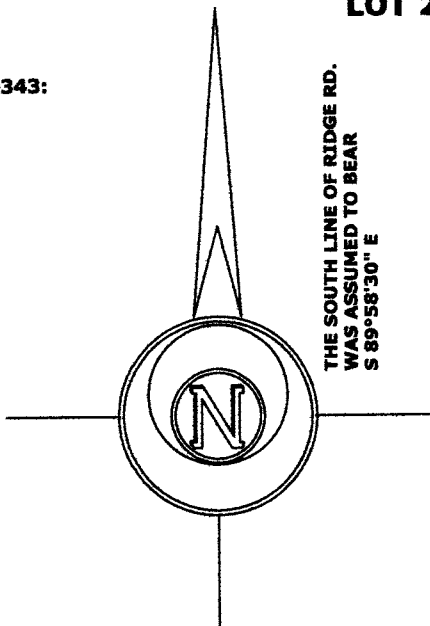
