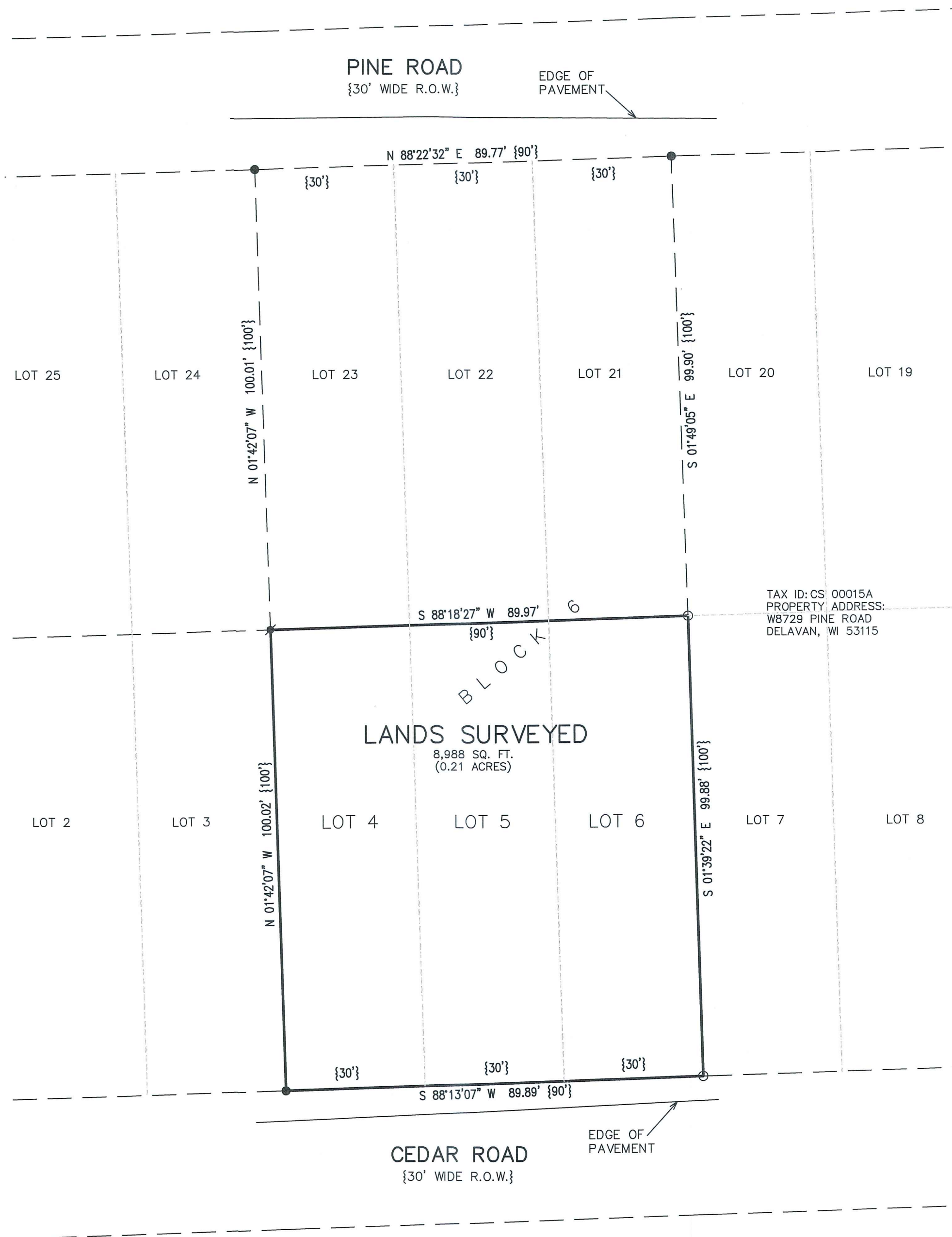


PLAT OF SURVEY LOTS 4 - 6 OF BLOCK 6 OF SKANSEN, A SUBDIVISION

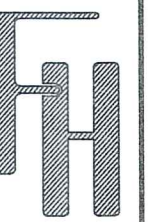
