Frame Walls Under Construction

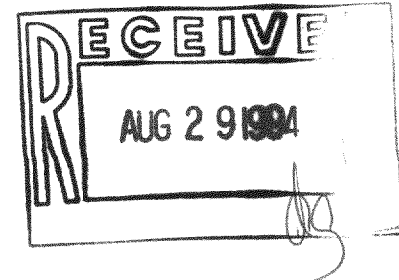

 Frame Walls Under Construction



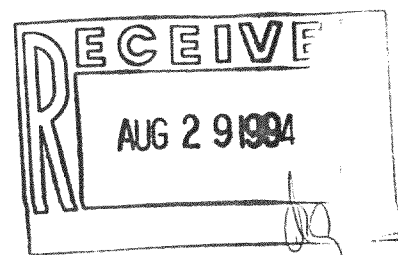
