LEGAL DESCRIPTION

LANDS LOCATED IN SECTION 11, TOWN 3 NORTH, RANGE 16 EAST, TOWN OF SUGAR CREEK, WALWORTH COUNTY, WISCONSIN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: LOT 1 AND LOT 2 OF BLOCK 38 OF INTERLAKEN, LOT 16 OF BLOCK 38 OF INTERLAKEN EXCEPTING THEREFROM THE EAST 1/2 OF THE SOUTH 1/2 OF SAID LOT 16, AND A PARCEL OF LAND SURVEY MAP NO. 785; THENCE SOUTHEAST CORNER OF LOT 1 OF SAID CERTIFIED SURVEY, 25.00 FEET; THENCE WESTERLY ALONG THE SOUTH LINE OF LOT 1 OF SAID CERTIFIED SURVEY, 25.00 FEET; THENCE NORTHERLY ALONG A LINE PARALLEL TO THE EAST LINE OF LOT 1 OF SAID CERTIFIED SURVEY, 100.00 FEET; THENCE EASTERLY ALONG A LINE PARALLEL TO THE SOUTH LINE OF LOT 1 OF SAID CERTIFIED SURVEY, 25.00 FEET TO THE EAST LINE OF LOT 1 OF SAID CERTIFIED SURVEY; THENCE ALONG SAID EAST LINE, 100.00 FEET TO THE POINT OF BEGINNING, CONTAINING 16,100 SQUARE FEET (0.37 ACRES) OF LAND, MORE OR LESS.



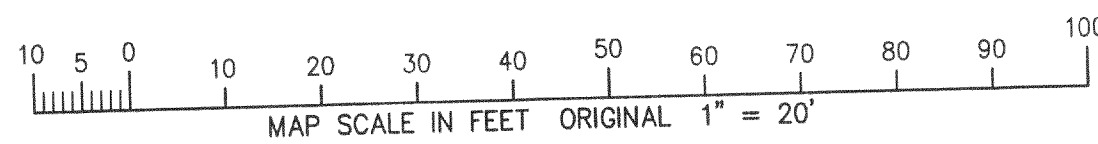
