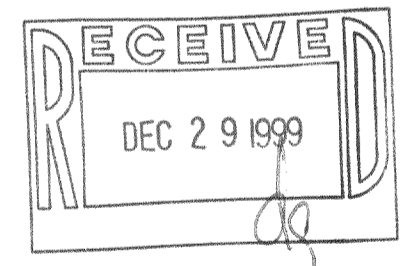

PARCEL 1 - LOTS 1-5 AND PART OF LOT 18, BLOCK 18 OF THE SECOND MAP OF INTERLAKEN, LOCATED IN T3N, R16E, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS: COMMENCING AT THE MOST EASTERLY CORNER OF LOT 9, BLOCK 19 OF SAID SECOND MAP OF INTERLAKEN; THENCE S 58°00'25" W ALONG THE SOUTH LINE OF SAID LOT 9, 124.91 FEET TO THE CENTERLINE OF IVY ROAD; THENCE N 31°56'32" W ALONG SAID CENTERLINE, 138.43 FEET TO THE PLACE OF BEGINNING; THENCE S 58°05'57" W 99.03 FEET; THENCE N 31°56'57" W 21.57 FEET; THENCE S 58°05'57" W 150.65 FEET TO THE CENTERLINE OF COUNTY HIGHWAY "E"; THENCE N 31°52'34" W ALONG SAID CENTERLINE, 176.87 FEET TO THE CENTERLINE OF COUNTY HIGHWAY "A"; THENCE 205.44 FEET ALONG THE ARC OF A 498.245 FOOT RADIUS CURVE TO THE LEFT AND SAID CENTERLINE, THE CHORD BEARING N 68°36'54" E 203.99 FEET; THENCE N 56°34'34" E ALONG SAID CENTERLINE, 48.95 FEET TO THE CENTERLINE OF SAID IVY ROAD; THENCE S 31°56'32" E ALONG SAID CENTERLINE, 162.51 FEET TO THE PLACE OF BEGINNING. CONTAINING 0.903 ACRES OR 39317 SQUARE FEET OF LAND MORE OR LESS.

PARCEL 2 - LOTS 6-8, THE NORTH 1/2 OF LOT 9, LOTS 19-21 AND PART OF LOT 18, BLOCK 18 OF THE SECOND MAP OF INTERLAKEN, LOCATED IN T3N, R16E, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS: COMMENCING AT THE MOST EASTERLY CORNER OF LOT 9, BLOCK 19 OF SAID SECOND MAP OF INTERLAKEN; THENCE S 58°00'25" W ALONG THE SOUTH LINE OF SAID LOT 9, 124.91 FEET TO THE CENTERLINE OF IVY ROAD AND THE PLACE OF BEGINNING; THENCE CONTINUE S 58°00'25" W 125.02 FEET; THENCE N 31°24'52" W 20.02 FEET; THENCE S 58°10'10" W 125.00 FEET TO THE CENTERLINE OF COUNTY HIGHWAY "E"; THENCE N 31°52'34" W ALONG SAID CENTERLINE, 140.00 FEET; THENCE N 58°05'57" E 150.65 FEET; THENCE S 31°56'57" E 21.57 FEET; THENCE N 58°05'57" E 99.03 FEET TO THE CENTERLINE OF SAID IVY ROAD; THENCE S 31°56'32" E ALONG SAID CENTERLINE, 138.43 FEET TO THE PLACE OF BEGINNING. CONTAINING 0.811 ACRES OR 35349 SQUARE FEET OF LAND MORE OR LESS.
