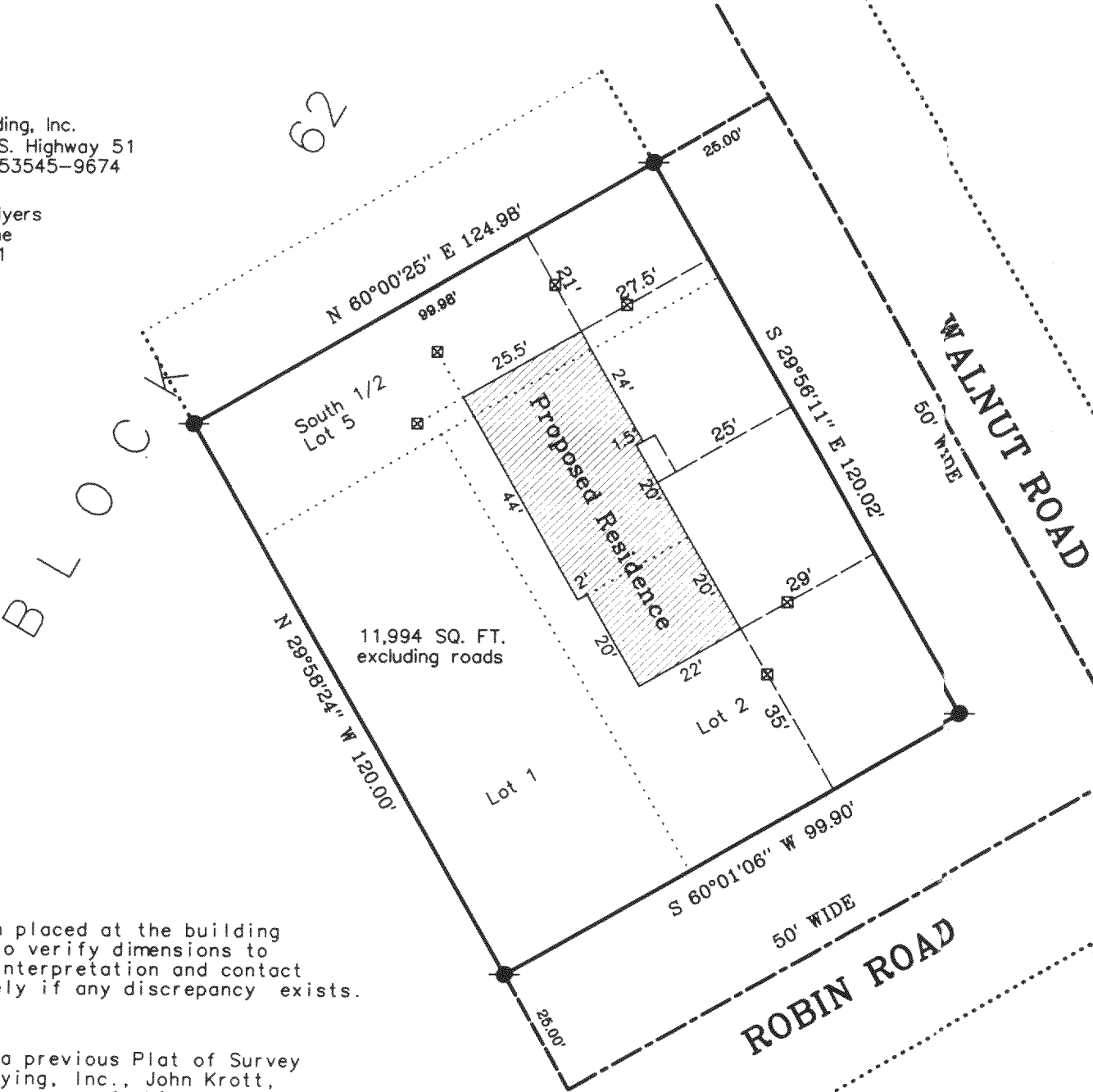

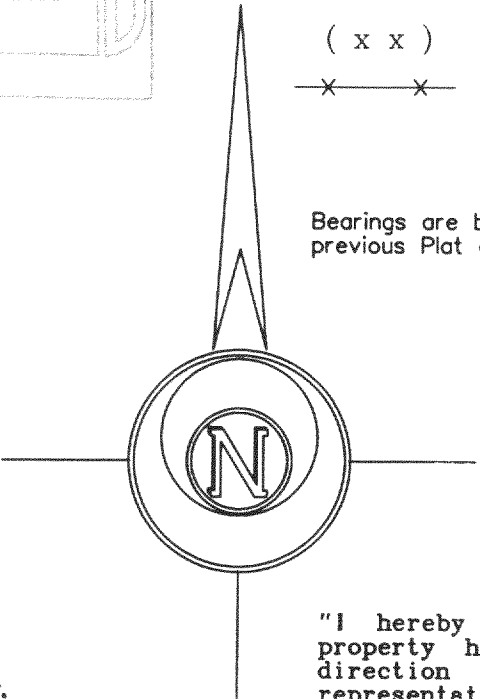
NOTES
