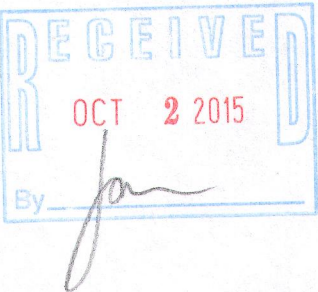
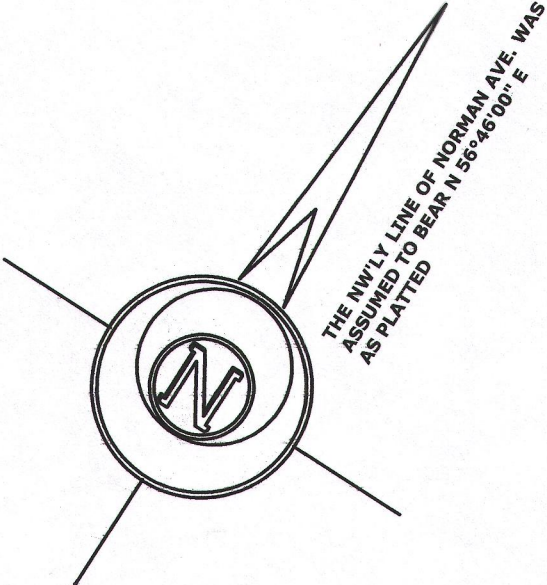
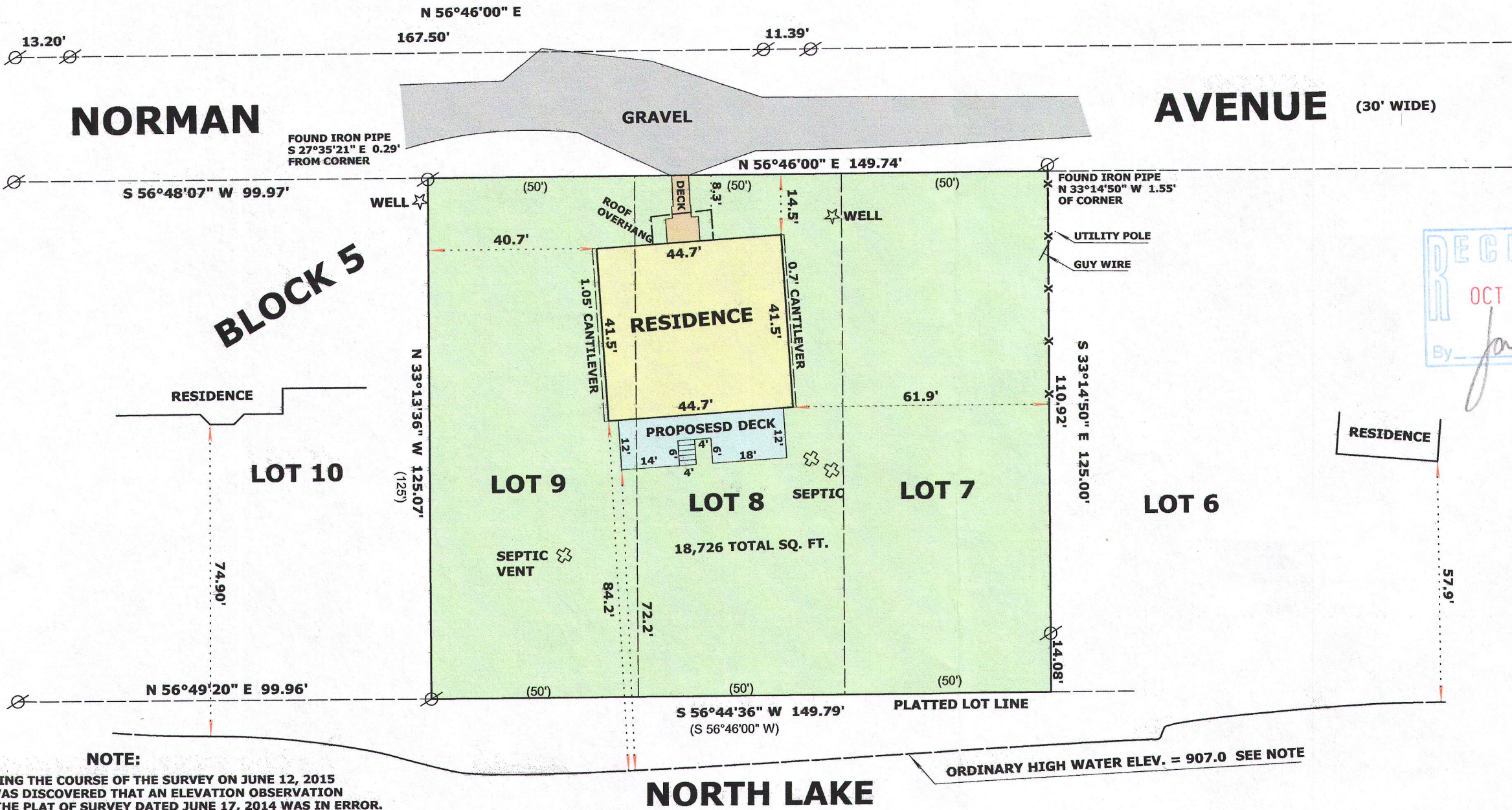

DURING THE COURSE OF THE SURVEY ON JUNE 12, 2015 IT WAS DISCOVERED THAT AN ELEVATION OBSERVATION ON THE PLAT OF SURVEY DATED JUNE 17, 2014 WAS IN ERROR. THE CORRECTED ORDINARY HIGH WATER LINE ELEVATION OF 907.0' IS SHOWN ON THIS PLAT. THE STATE OF WISCONSIN OWNS THE LAKE BEDS TO THE ORDINARY HIGH WATER LINE (OHW). THE ELEVATION SET BY WI DNR FOR NORTH LAKE IS 907.0'. BENCHMARK USED WAS CENTER OF SECTION 5-3-16 WITH AN ELEVATION OF 910.65' (NGVD 1929)
