## EXHIBIT A

Parcel I: All that part of the Southwest 1/4 of Section 1, Town 3 North, Range 16 East, Town of Sugar Cruck, County of Walworth, State of Wisconsin, bounded and described as follows: Commencing at a point in the Southerly edge of Wandawega Drive where the same intersects the Westerly edge of U.S. Highway 12 right of way in the Southwest 1/4 of said Section 1, thence running Southerly along the Westerly edge of U.S. Highway 12, 225 feet to a point, thence West 250 feet to a point, thence N parallel with U.S. Highway 12, 225 feet more or jess to a point on the S'ly edge of Wandawega Drive aforesaid, thence E'ly along the S'ly edge of Wandawega Drive, 250 f at to the point of beginning.
