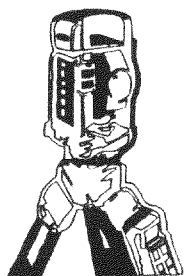
CENTER LINE OF EXISTING DITCH

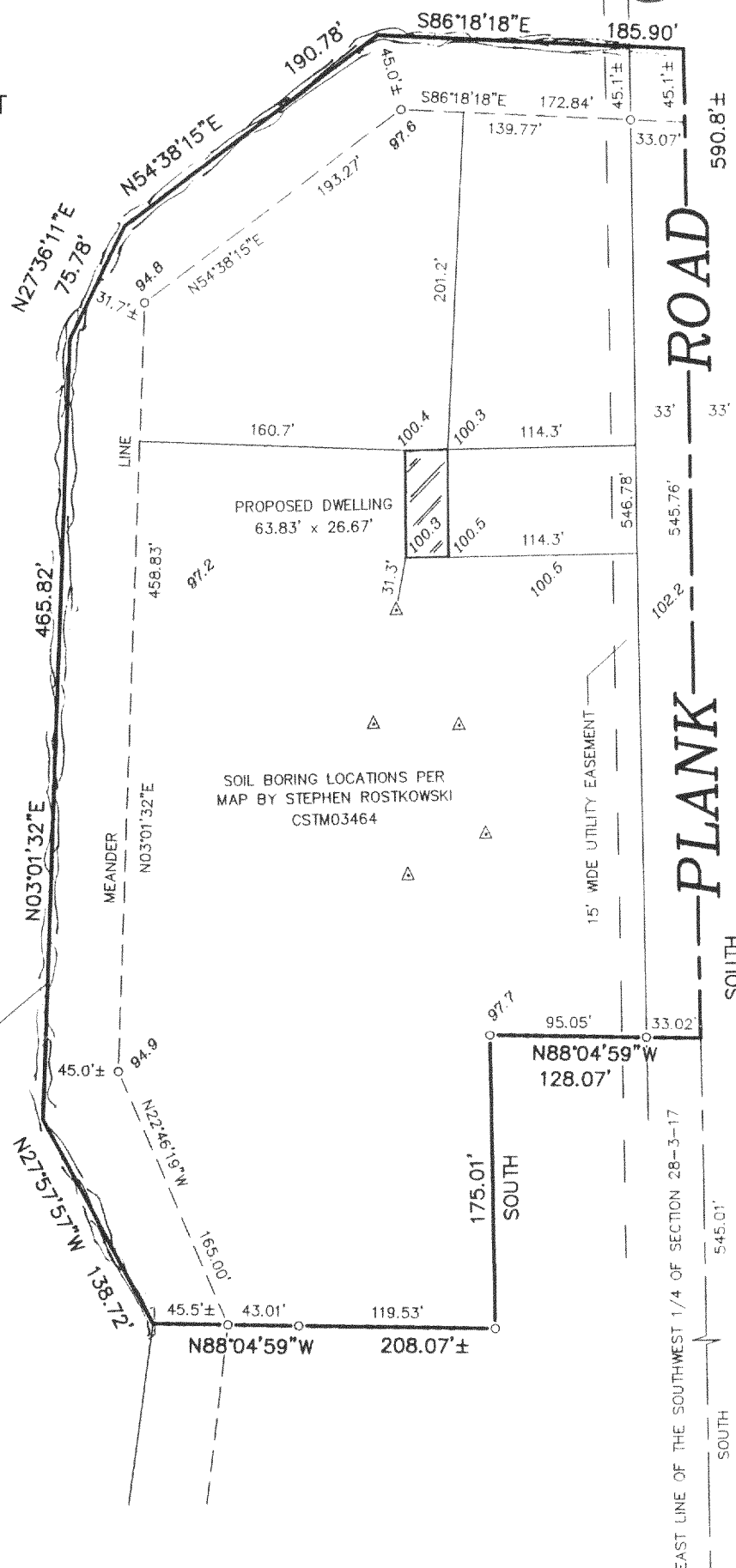

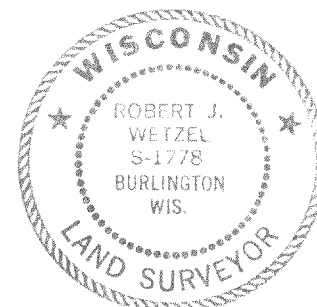
