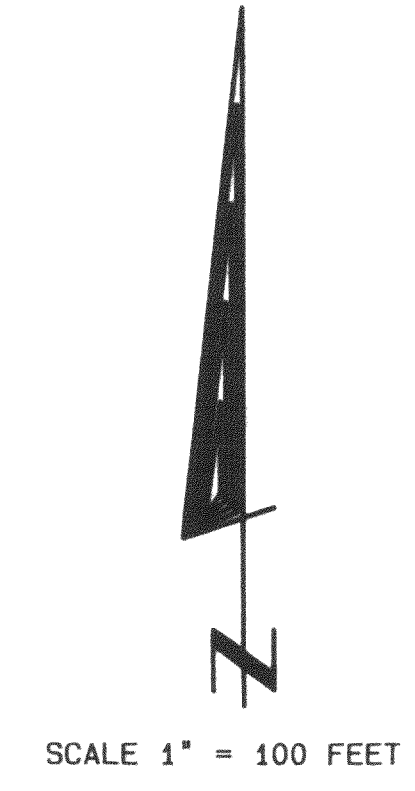
EXISTING C-2 ZONING

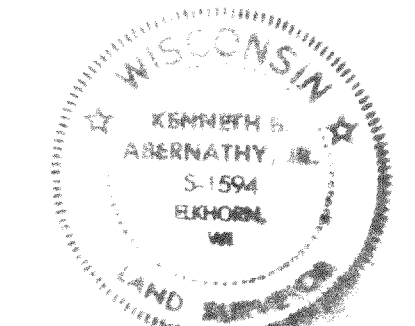
