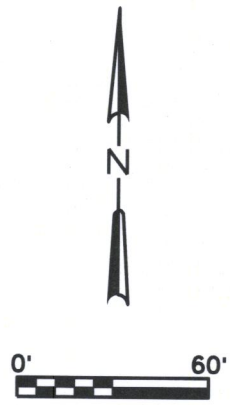


PLAT OF SURVEY

MAP No. 2088, SAID POINT BEING THE POINT OF BEGINNING FOR THIS PARCEL; THENCE S67°44'58"E ALONG THE NORTHEAST LINE OF SAID LOT 1, 529.95' TO A FOUND IRON PIPE ON THE SOUTHWESTERLY RIGHT OF WAY FOR STATE TRUNK HIGHWAY "120"; THENCE S25°38'53"W ALONG SAID RIGHT OF WAY, 367.68' TO A FOUND IRON PIPE; THENCE N62°55'23"W ALONG THE SOUTHERLY LINE OF SAID LOT 1, 536.99' TO A FOUND IRON PIPE MARKING THE SOUTHWEST CORNER OF SAID LOT 1; THENCE N27°01'58"E, 322.97' TO THE POINT OF BEGINNING.

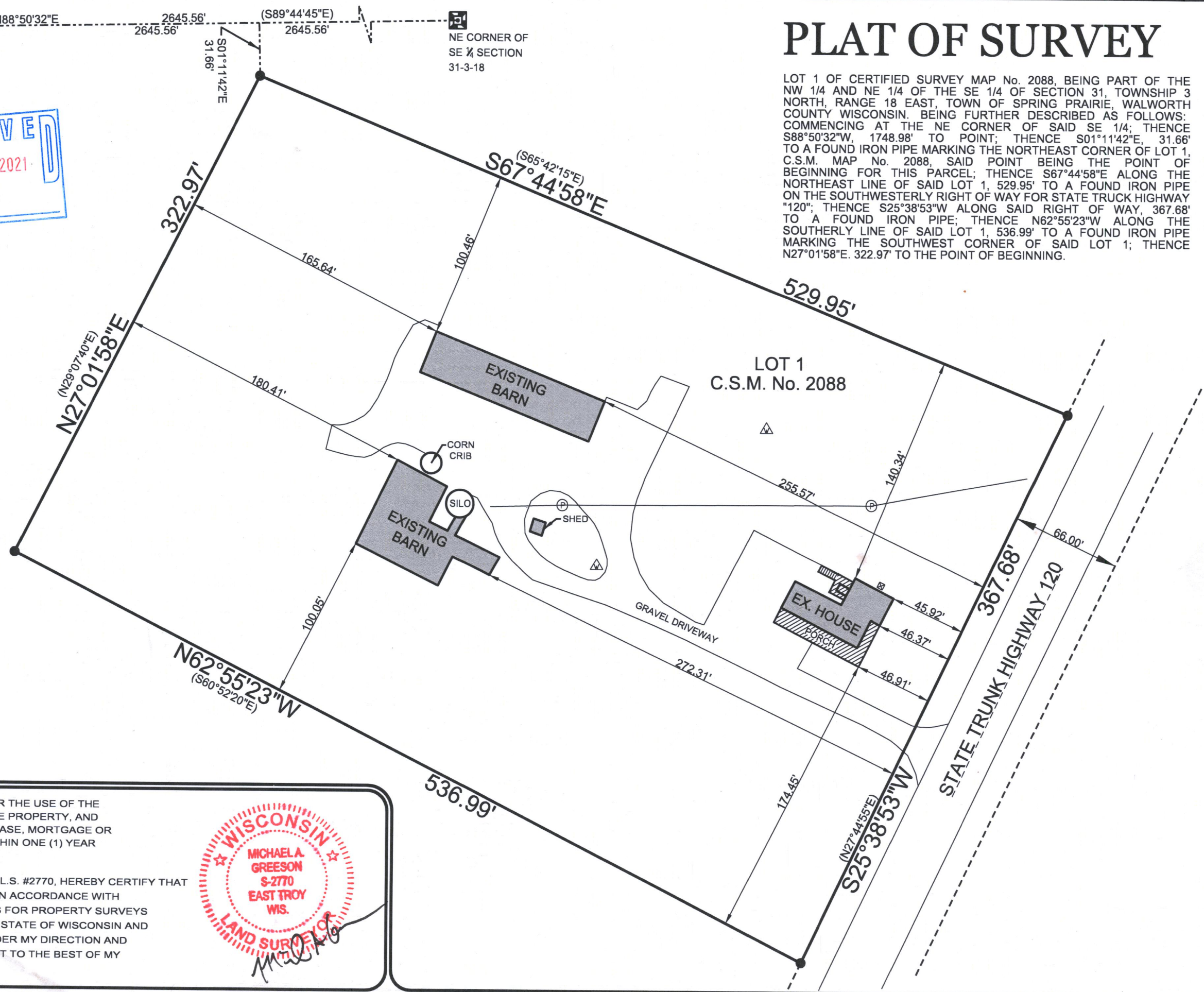
