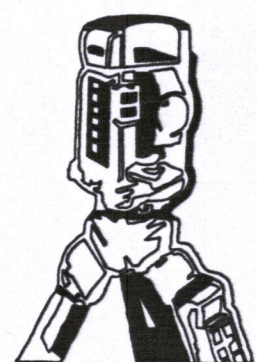
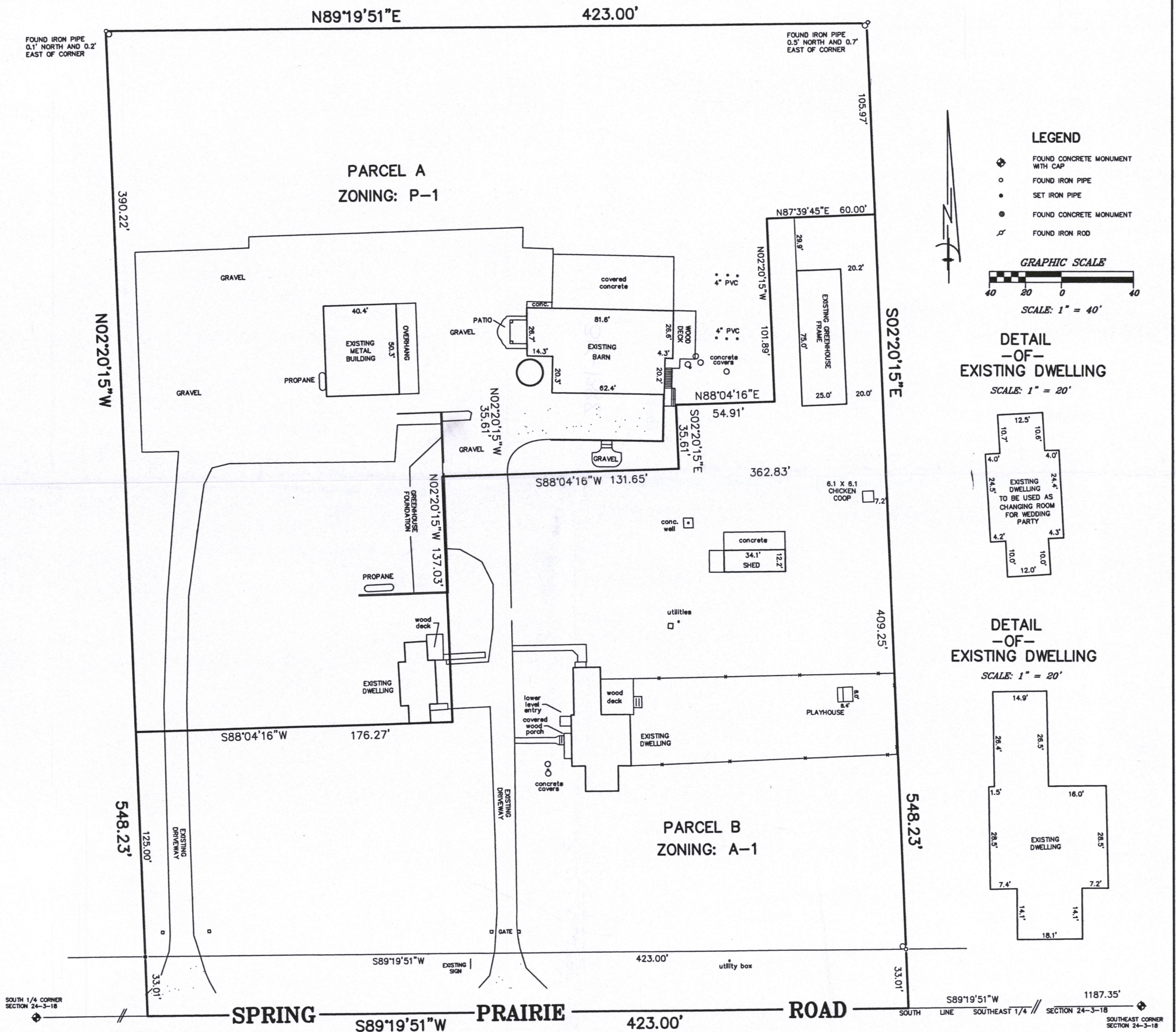

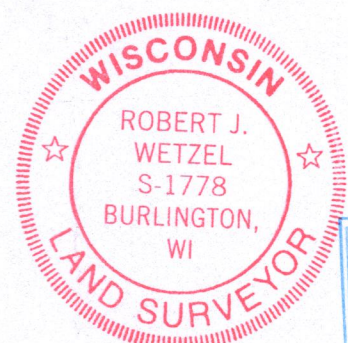

SURVEY LOCATION: W212 SPRING PRAIRIE ROAD



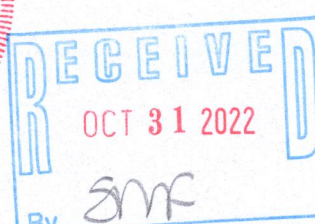
