"D"; THENCE SOUTHWESTERLY ALONG SAID CENTERLINE TO THE WEST LINE OF THE SOUTHEAST 1/4 OF SECTION 2; THENCE NORTH 1°59'46" WEST, ALONG THE WEST LINE OF SAID 1/4, 123.47 FEET TO THE POINT OF BEGINNING. 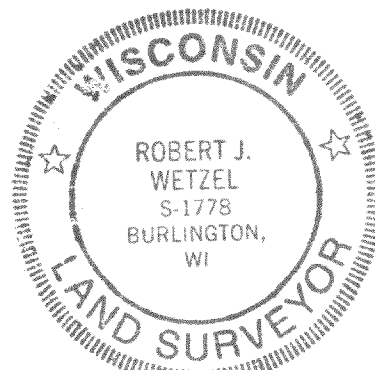
