

PLAT OF SURVEY AND LEGAL DESCRIPTIONS
FOR PROPOSED LOT LINE ADJUSTMENTS

PARCEL 1:

COMMENCE AT THE NORTHWEST CORNER OF LOT 4, BLOCK 4, HONEY LAKE SUBDIVISION, ACCORDING TO THE RECORDED PLAT THEREOF; THENCE NORTH 11°18'29" WEST (RECORDED AS NORTH 11°17' WEST) ALONG THE EASTERLY LINE OF LAKESHORE DRIVE, 35.72 FEET TO THE SOUTHWEST CORNER OF LOT 9, BLOCK 3, HONEY LAKE SUBDIVISION, AND POINT OF BEGINNING OF THE LANDS HEREINAFTER DESCRIBED; THENCE SOUTH 89°48'00" EAST ALONG THE NORTH LINE OF PLEASANT AVENUE, 187.76 FEET (RECORDED AS 188.00 FEET) TO THE SOUTHEAST CORNER OF LOT 11, BLOCK 3, HONEY LAKE SUBDIVISION; THENCE SOUTH 00°04'11" EAST 17.50 FEET; THENCE NORTH 89°48'00" WEST 184.28 FEET TO A POINT ON THE EASTERLY LINE OF LAKESHORE DRIVE; THENCE NORTH 11°18'29" WEST (RECORDED AS NORTH 11°17' WEST) ALONG SAID EASTERLY LINE 17.86 FEET TO THE POINT OF BEGINNING. CONTAINING 3,255 SQUARE FEET, MORE OR LESS. SAID LAND BEING IN THE TOWN OF SPRING PRAIRIE, COUNTY OF WALWORTH AND STATE OF WISCONSIN.

PARCEL 2:

BEGIN AT THE NORTHWEST CORNER OF LOT 4, BLOCK 4, HONEY LAKE SUBDIVISION, ACCORDING TO THE RECORDED PLAT THEREOF; THENCE NORTH 11°18'29" WEST (RECORDED AS NORTH 11°17' WEST) ALONG THE EASTERLY LINE OF LAKESHORE DRIVE, 17.86 FEET; THENCE SOUTH 89°48'00" EAST 126.12 FEET; THENCE SOUTH 08°08'57" EAST 17.69 FEET TO THE NORTHEAST CORNER OF SAID LOT 4; THENCE NORTH 89°48'00" WEST ALONG THE NORTH LINE OF SAID LOT 4, ALSO BEING THE SOUTH LINE OF PLEASANT AVENUE, 125.12 FEET (RECORDED AS 125.30 FEET) TO THE POINT OF BEGINNING. CONTAINING 2,198 SQUARE FEET, MORE OR LESS. SAID LAND BEING IN THE TOWN OF SPRING PRAIRIE, COUNTY OF WALWORTH AND STATE OF WISCONSIN.

PARCEL 3:

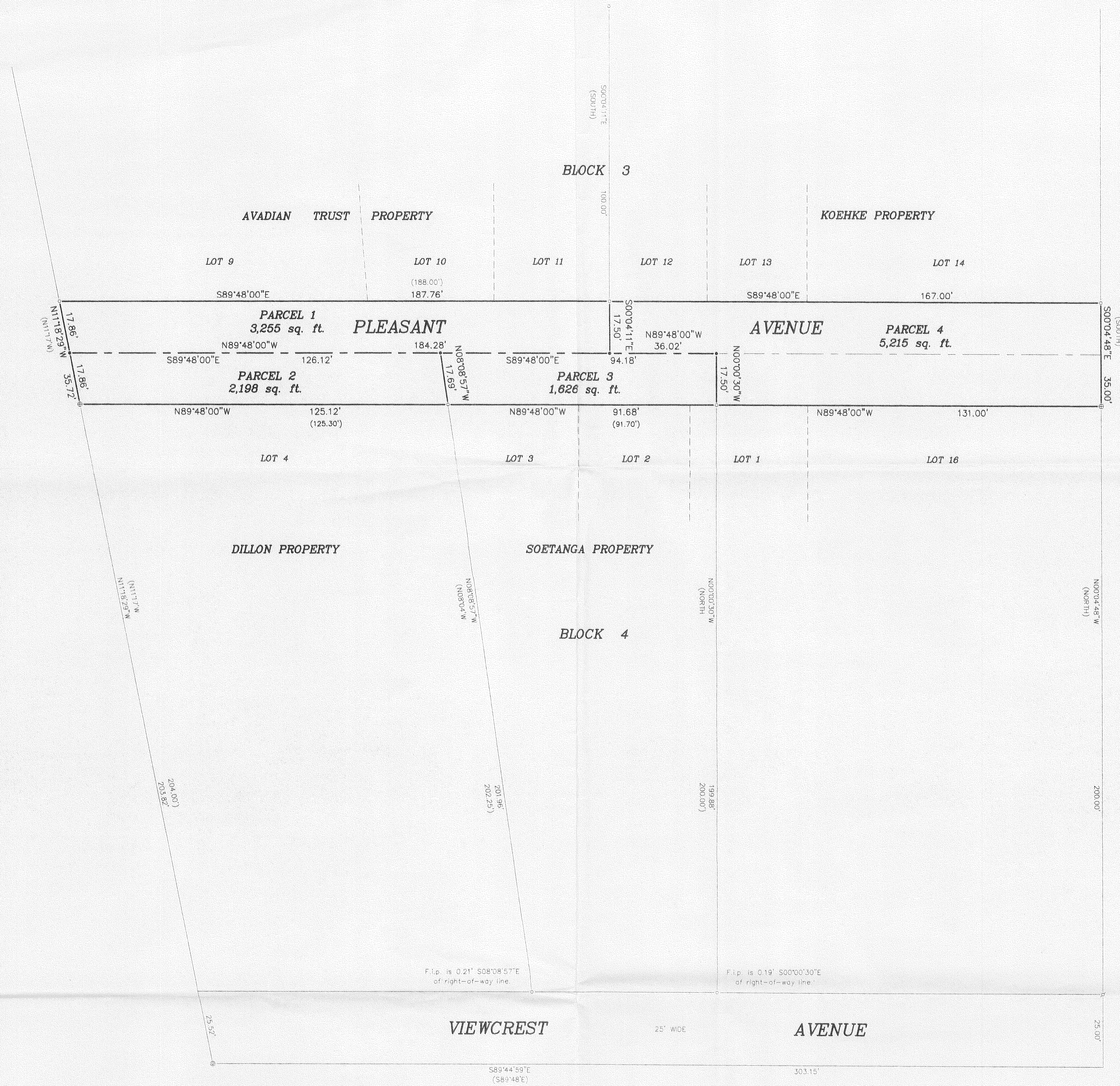
COMMENCE AT THE NORTHWEST CORNER OF LOT 4, BLOCK 4, HONEY LAKE SUBDIVISION, ACCORDING TO THE RECORDED PLAT THEREOF; THENCE SOUTH 89°48'00" EAST ALONG THE NORTH LINE OF SAID LOT 4, ALSO BEING THE SOUTH LINE OF PLEASANT AVENUE, 125.12 FEET (RECORDED AS 125.30 FEET) TO THE NORTHWEST CORNER OF LOT 3, BLOCK 4, HONEY LAKE SUBDIVISION, AND THE POINT OF BEGINNING OF THE PARCEL OF LAND HEREINAFTER DESCRIBED; THENCE NORTH 08°08'57" WEST 17.69 FEET; THENCE SOUTH 89°48'00" EAST 94.18 FEET; THENCE SOUTH 00°00'30" EAST 17.50 FEET TO A POINT ON THE SOUTH LINE OF PLEASANT AVENUE; THENCE NORTH 89°48'00" WEST ALONG SAID SOUTH LINE 91.68 FEET (RECORDED AS 91.70 FEET) TO THE POINT OF BEGINNING. CONTAINING 1,626 SQUARE FEET, MORE OR LESS. SAID LAND BEING IN THE TOWN OF SPRING PRAIRIE, COUNTY OF WALWORTH AND STATE OF WISCONSIN.

PARCEL 4:

BEGIN AT THE NORTHEAST CORNER OF LOT 16, BLOCK 4, HONEY LAKE SUBDIVISION, ACCORDING TO THE RECORDED PLAT THEREOF; THENCE NORTH 89°48'00" WEST ALONG THE SOUTH LINE OF PLEASANT AVENUE 131.00 FEET; THENCE NORTH 00°00'30" WEST 17.50 FEET; THENCE NORTH 89°48'00" WEST 36.02 FEET; THENCE NORTH 00°04'11" WEST 17.50 FEET TO THE SOUTHWEST CORNER OF LOT 12, BLOCK 3, HONEY LAKE SUBDIVISION; THENCE SOUTH 89°48'00" EAST ALONG THE NORTH LINE OF PLEASANT AVENUE 167.00 FEET TO THE SOUTHEAST CORNER OF LOT 14, BLOCK 3, HONEY LAKE SUBDIVISION, AND A POINT ON THE WEST LINE OF COUNTY LINE BOULEVARD; THENCE SOUTH 00°04'48" EAST (RECORDED AS SOUTH) ALONG SAID WEST LINE 35.00 FEET TO THE POINT OF BEGINNING. CONTAINING 5,215 SQUARE FEET, MORE OR LESS. SAID LAND BEING IN THE TOWN OF SPRING PRAIRIE, COUNTY OF WALWORTH AND STATE OF WISCONSIN.

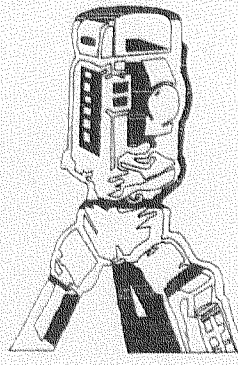

ACCEPTED FOUND MONUMENTS AS BEST EVIDENCE OF LOT LINES.



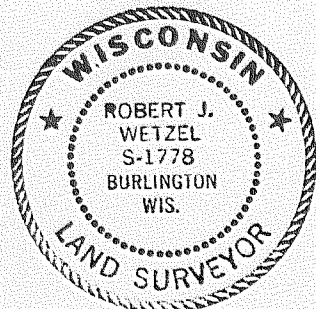

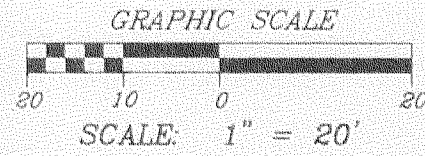

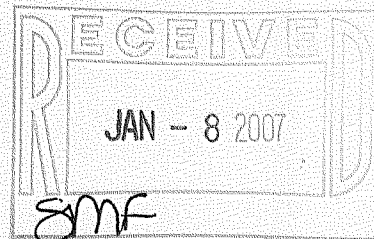
