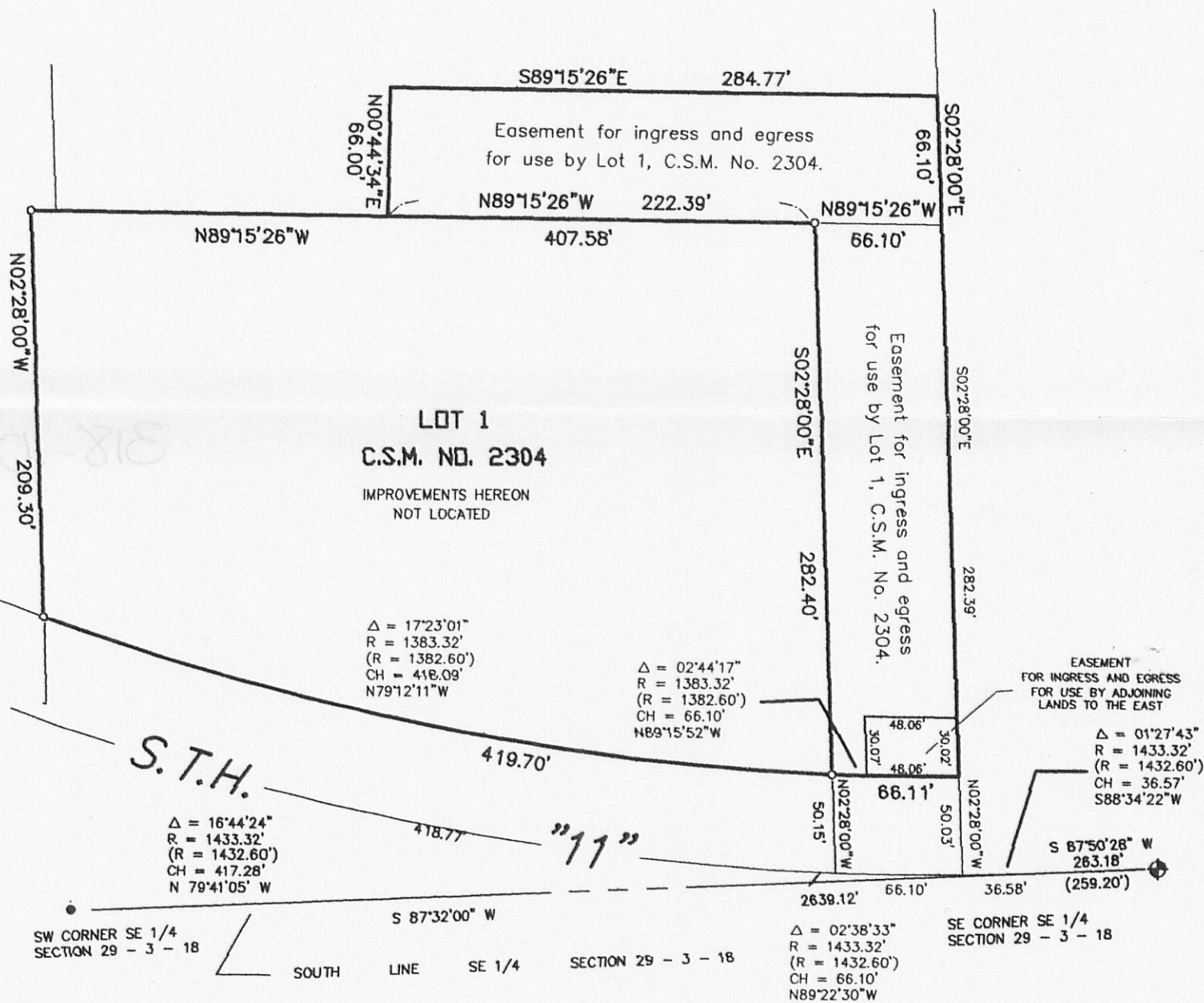
TOGETHER WITH AN EASEMENT FOR INGRESS AND EGRESS DESCRIBED AS FOLLOWS:

THAT PART OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 29, TOWNSHIP 3 NORTH, RANGE 18 EAST OF THE FOURTH PRINCIPAL MERIDIAN, IN THE TOWN OF SPRING PRAIRIE, WALWORTH COUNTY, WISCONSIN AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AT THE SOUTHEAST CORNER OF SAID SOUTHEAST 1/4 SECTION; THENCE SOUTH 87°50'28" WEST 263.18 FEET (RECORDED AS 259.20 FEET) TO A POINT OF CURVATURE; THENCE SOUTHWESTERLY 36.58 FEET ALONG THE ARC OF SAID CURVE BEING A CURVE TO THE RIGHT, HAVING A RADIUS OF 1433.32 FEET (RECORDED AS 1432.60 FEET), A CENTRAL ANGLE OF 01°27'43", AND WHOSE LONG CHORD BEARS SOUTH 88°34'22" WEST 36.57 FEET; THENCE NORTH 02°28'00" WEST 50.03 FEET TO A POINT ON THE NORTH LINE OF STATE TRUNK HIGHWAY "11" AND THE PLACE OF BEGINNING OF THIS DESCRIPTION; THENCE NORTHWESTERLY 66.11 FEET ALONG SAID NORTH LINE BEING THE ARC OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 1383.32 FEET (RECORDED AS 1382.60 FEET), A CENTRAL ANGLE OF 02°44'17", AND WHOSE LONG CHORD BEARS NORTH 89°15'52" WEST 66.10 FEET TO THE SOUTHEAST CORNER OF CERTIFIED SURVEY MAP NO. 2304; THENCE NORTH 02°28'00" WEST ALONG THE EAST LINE OF SAID MAP 282.40 FEET TO THE NORTHEAST CORNER OF SAID MAP; THENCE SOUTH 89°15'26" EAST 66.10 FEET; THENCE SOUTH 02°28'00" EAST 282.39 FEET TO THE PLACE OF BEGINNING.

ALSO TOGETHER WITH AN EASEMENT FOR INGRESS AND EGRESS DESCRIBED AS FOLLOWS:

THAT PART OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 29, TOWNSHIP 3 NORTH, RANGE 18 EAST OF THE FOURTH PRINCIPAL MERIDIAN, IN THE TOWN OF SPRING PRAIRIE, WALWORTH COUNTY, WISCONSIN AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AT THE NORTHEAST CORNER OF LOT 1 OF CERTIFIED SURVEY MAP NO. 2304 AS RECORDED IN THE OFFICE OF THE REGISTER OF DEEDS IN AND FOR WALWORTH COUNTY, WISCONSIN; THENCE NORTH 89°15'26" WEST ALONG THE NORTH LINE OF SAID LOT 1, 222.39 FEET; THENCE NORTH 00°44'34" EAST 66.00 FEET; THENCE SOUTH 89°15'26" EAST 284.77 FEET; THENCE SOUTH 02°28'00" EAST 66.10 FEET; THENCE NORTH 89°15'26" WEST 66.10 FEET TO THE PLACE OF BEGINNING OF THIS EASEMENT

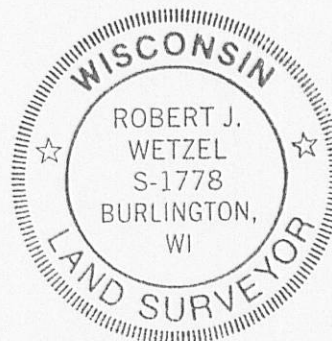

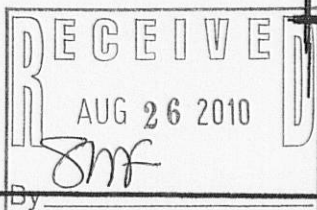
