 THAT PART OF BLOCK 9 OF THE FIRST ADDITION TO HONEY LAKE SUBDIVISION AND THAT PART OF THE SOUTHEAST 1/4 OF SECTION 13, TOWNSHIP 3 NORTH, RANGE 18 EAST OF THE FOURTH PRINCIPAL MERIDIAN, IN THE TOWN OF SPRING PRAIRIE, WALWORTH COUNTY, WISCONSIN AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AT THE NORTHEAST CORNER OF LOT 11, BLOCK 9 OF SAID FIRST ADDITION TO HONEY LAKE SUBDIVISION; THENCE SOUTH 01°06' WEST (RECORDED AS SOUTH 00°03' EAST) ALONG THE EAST LINE OF SAID LOT 11, 108.20 FEET TO THE PLACE OF BEGINNING OF THIS DESCRIPTION; THENCE CONTINUE SOUTH 01°06' WEST ALONG THE SOUTHERLY EXTENSION OF SAID EAST LINE 16 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK OF THE SHORE OF HONEY LAKE; THENCE SOUTHWESTERLY ALONG THE ORDINARY HIGH WATER MARK OF THE SHORE OF SAID HONEY LAKE 30 FEET MORE OR LESS TO A POINT SOUTH 60°24'55" EAST 57.50 FEET FROM THE INTERSECTION OF THE PLATTED SHORELINE OF HONEY LAKE AND THE WEST LINE OF LOT 10, BLOCK 9, FIRST ADDITION TO HONEY LAKE SUBDIVISION; THENCE NORTH 60°24'55" WEST 57.50 FEET; THENCE SOUTHEASTERLY ALONG SAID PLATTED SHORELINE 79.60 FEET MORE OR LESS TO THE PLACE OF BEGINNING.

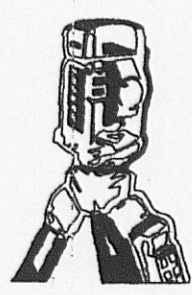
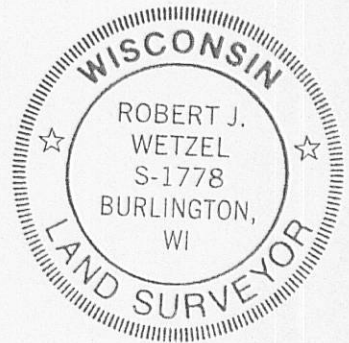
