

CONTAINING 21.14 ACRES.

A PARCEL OF LAND LOCATED IN THE NORTH 1/2 OF SECTION 10, TOWN 3 NORTH; RANGE 18 EAST, WALWORTH COUNTY, WISCONSIN, AND DESCRIBED AS FOLLOWS: COMMENCING AT THE EAST 1/4 CORNER OF SAID SECTION 10; THENCE N 88°54' W 2063.24 FEET ALONG THE EAST-WEST 1/4 LINE; THENCE CONTINUE N 88°54' W 67.05 FEET TO THE POINT OF BEĞINNING; THENCE N 1°11' W 522.78 FEET; THENCE N 88°54' W 510.50 FEET; THENCE S 19°31' E 321.86 FEET; THENCE S 3°24' E 221.80 FEET; THENCE S 88°54' E 400.65 FEET TO THE POINT OF BEĞINNING, CONTAINING 5.24 ACRES. (COMPUTED FROM EXISTING SURVEY RECORDS.)
