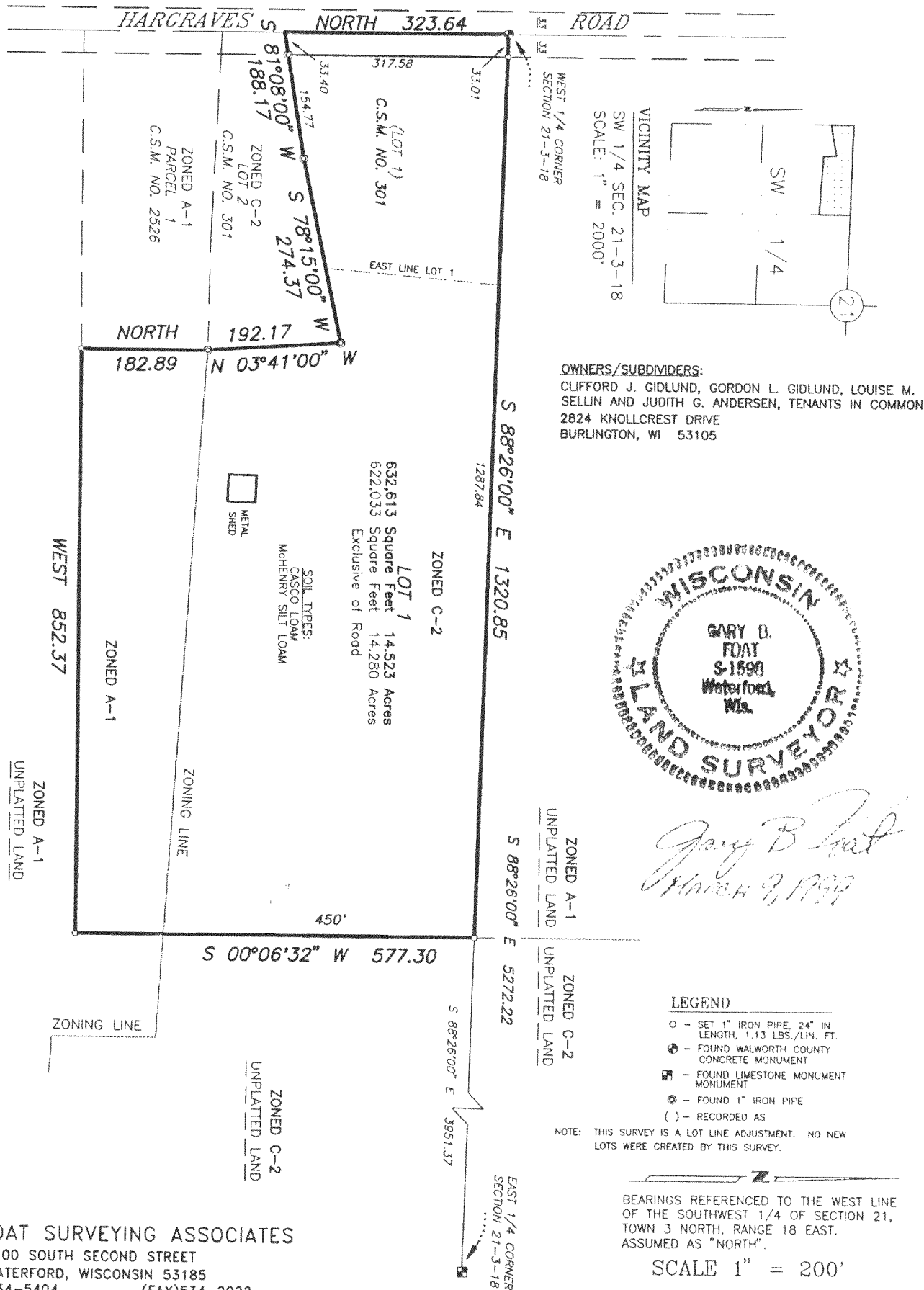

FOAT, WISCONSIN REGISTERED LAND SURVEYOR, DO HEREBY CERTIFY THAT I HAVE SURVEYED, DIVIDED, AND MAPPED ALL OF LOT 1 OF WALWORTH COUNTY CERTIFIED SURVEY MAP NO. 301 AND PART OF THE NORTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 21, TOWN 3 NORTH, RANGE 18 EAST, TOWN OF SPRING PRAIRIE, WALWORTH COUNTY, WISCONSIN AND MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE WEST 1/4 OF SECTION 21; THENCE S 88°26'00" E ALONG THE NORTH LINE OF THE SOUTHWEST 1/4 OF SAID SECTION, 1320.85 FEET; THENCE S 00°06'32" W 577.30 FEET; THENCE WEST 852.37 FEET; THENCE NORTH 182.89 FEET TO THE SOUTHEAST CORNER OF LOT 2 OF WALWORTH COUNTY CERTIFIED SURVEY MAP NO 301; THENCE N 03°41'00" W ALONG THE EAST LINE OF SAID LOT 2, 192.17 FEET; THENCE S 78°15'00" W ALONG THE NORTH LINE OF SAID LOT 2, 274.37 FEET; THENCE S 81°08'00" W ALONG THE NORTH LINE OF SAID LOT 2, 188.17 FEET TO THE WEST LINE OF SOUTHWEST 1/4 OF SAID SECTION; THENCE NORTH ALONG THE WEST LINE OF THE SOUTHWEST 1/4 OF SAID SECTION 323.64 FEET TO THE POINT OF BEGINNING.
