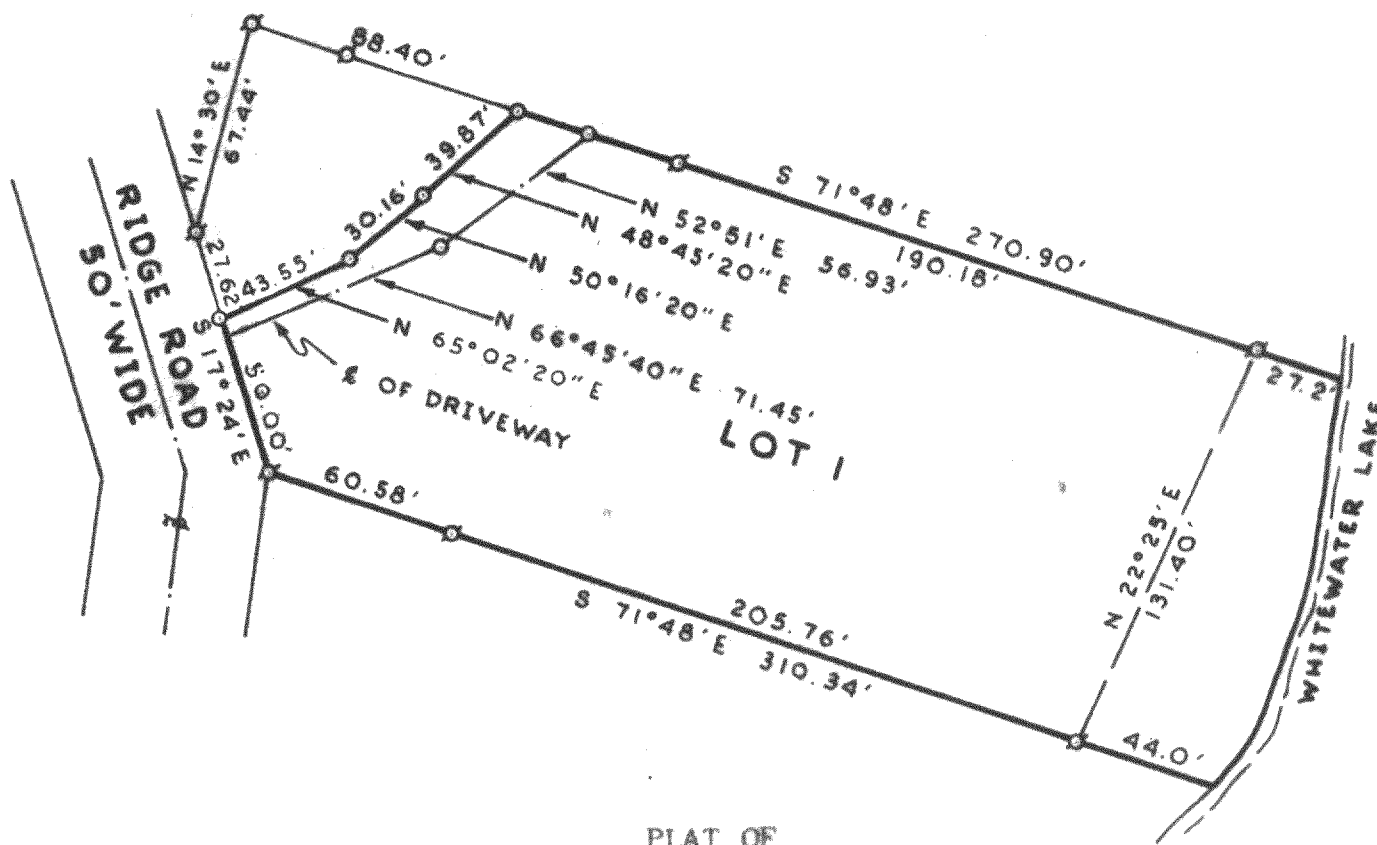

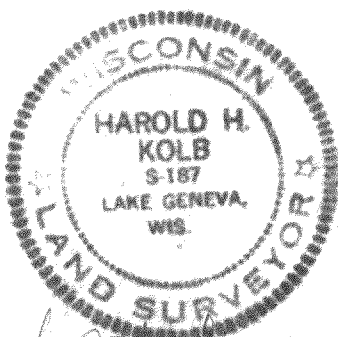

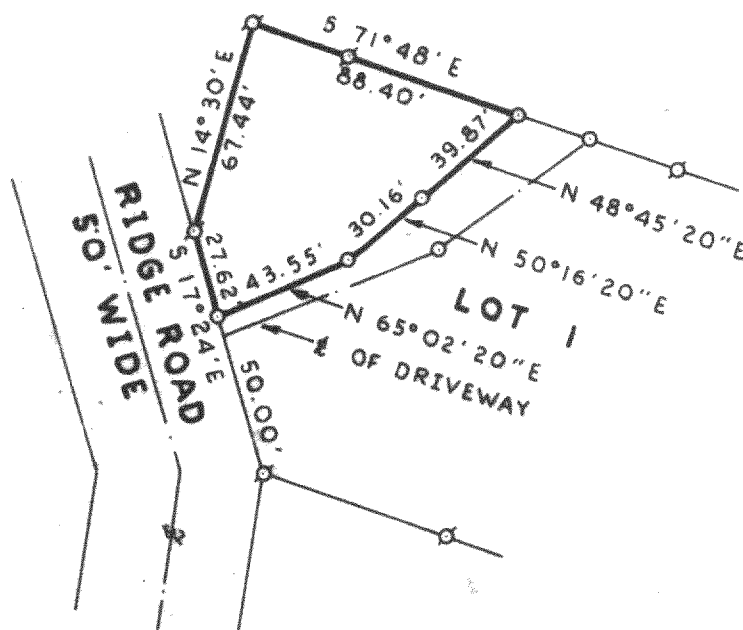

Lot 1 of Cert Survey 97

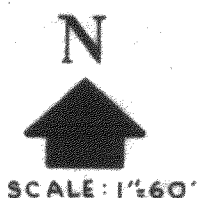

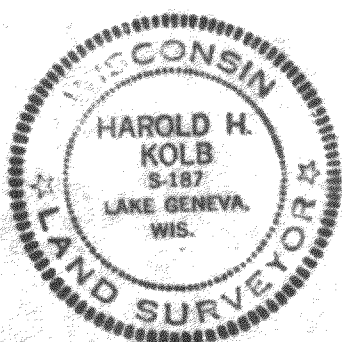
