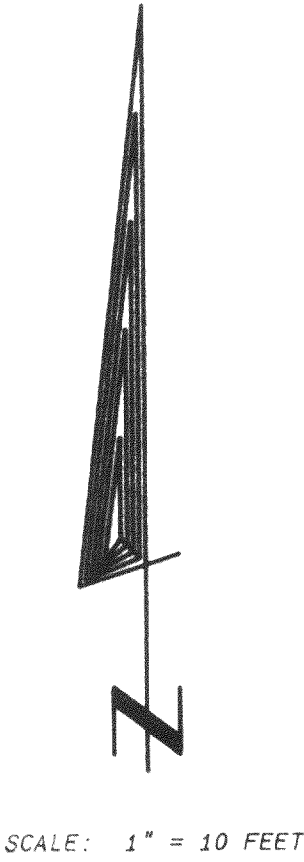

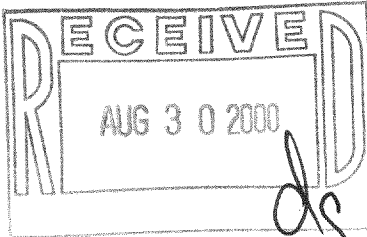
LOT 18, BLOCK 1, MORaine HEIGHTS
