

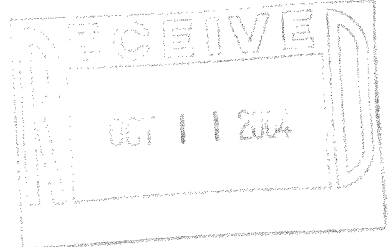

Lot 8 of Thorne Heights Subdivision, according to the recorded plat thereof, being a subdivision of a part of the Southeast 1/4 and the Southwest 1/4 of Section 35, Town 4 North, Range 15 East, Walworth County, Wisconsin, excepting therefrom a parcel of land located in Lot 8 of Thorne Heights Subdivision, a subdivision located in Section 35, T4N, R15E, Walworth County, Wisconsin and described as follows, to-wit: Beginning at the Southwest corner of said Lot 8; thence N 0° 34' W 78.85 feet along the West line of said Lot 8; thence S 72° 38' E 178.52 feet along a line that is located 75 feet Northeast of and parallel to the Southwesterly line of said lot; thence S 60° 22' E 54.35 feet to the Northwestern line of East Shore Drive; thence S 39° 33' W 68.54 feet along said road line to the Southeast corner of said Lot 8; thence N 72° 38' W 181.39 feet along the lot line to the place of beginning.
