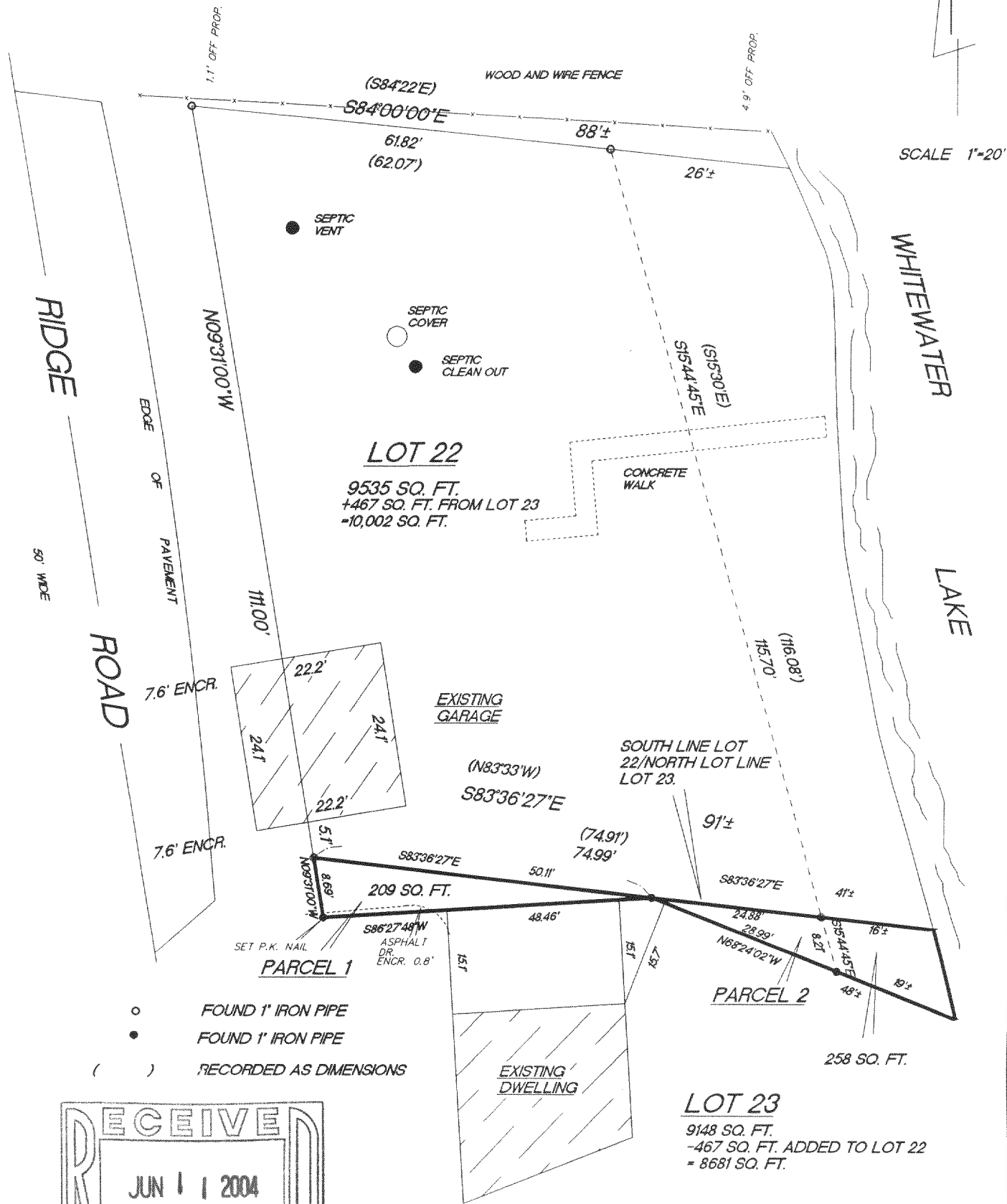


LOT LINE ADJUSTMENT

THE WALWORTH COUNTY CODE OF ORDINANCES (ZONING/SHORELAND ZONING).

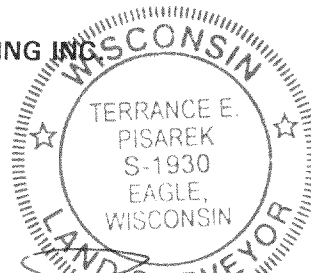

**LOT LINE ADJUSTMENT
TO BE ADDED TO LOT 22, BLOCK 1 MORaine HEIGHTS**

Parcel 1: All that part of lot 23, Block 1, Moraine Heights, a Subdivision in the Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 26, and the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 26, and the Northwest $\frac{1}{4}$ of Section 35, and the Northeast $\frac{1}{4}$ of Section 35, and the Southwest $\frac{1}{4}$ of Section 35, Town 4 North, Range 15 East, Town of Whitewater, Walworth County, described as follows: Beginning at the Northwest corner of said Lot 23; thence South $83^{\circ}36'27''$ East along the North line of said Lot 23, 50.11 feet; thence South $86^{\circ}27'48''$ West 48.46 feet; to the West line of said Lot 23; thence North $09^{\circ}31'00''$ West along said West line, 8.69 feet to the place of beginning, containing 209 sq. ft.

Parcel 2: All that part of lot 23, Block 1, Moraine Heights, a Subdivision in the Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 26, and the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 26, and the Northwest $\frac{1}{4}$ of Section 35, and the Northeast $\frac{1}{4}$ of Section 35, and the Southwest $\frac{1}{4}$ of Section 35, Town 4 North, Range 15 East, Town of Whitewater, Walworth County, described as follows: Commencing at the Northwest corner of said Lot 23; thence South $83^{\circ}36'27''$ East along the North line of said Lot 23, 50.11 feet, to the place of beginning; thence continuing South $83^{\circ}36'27''$ East along the North line of said Lot 23, 24.88 feet to the meander line of said Lot 23; thence South $15^{\circ}44'45''$ East along said meander line, 8.21 feet; thence North $68^{\circ}24'02''$ West 28.99 feet to the place of beginning, also those lands between said meander line and Whitewater Lake lying between the above described lines extended to Whitewater Lake, containing 258 sq. ft.
