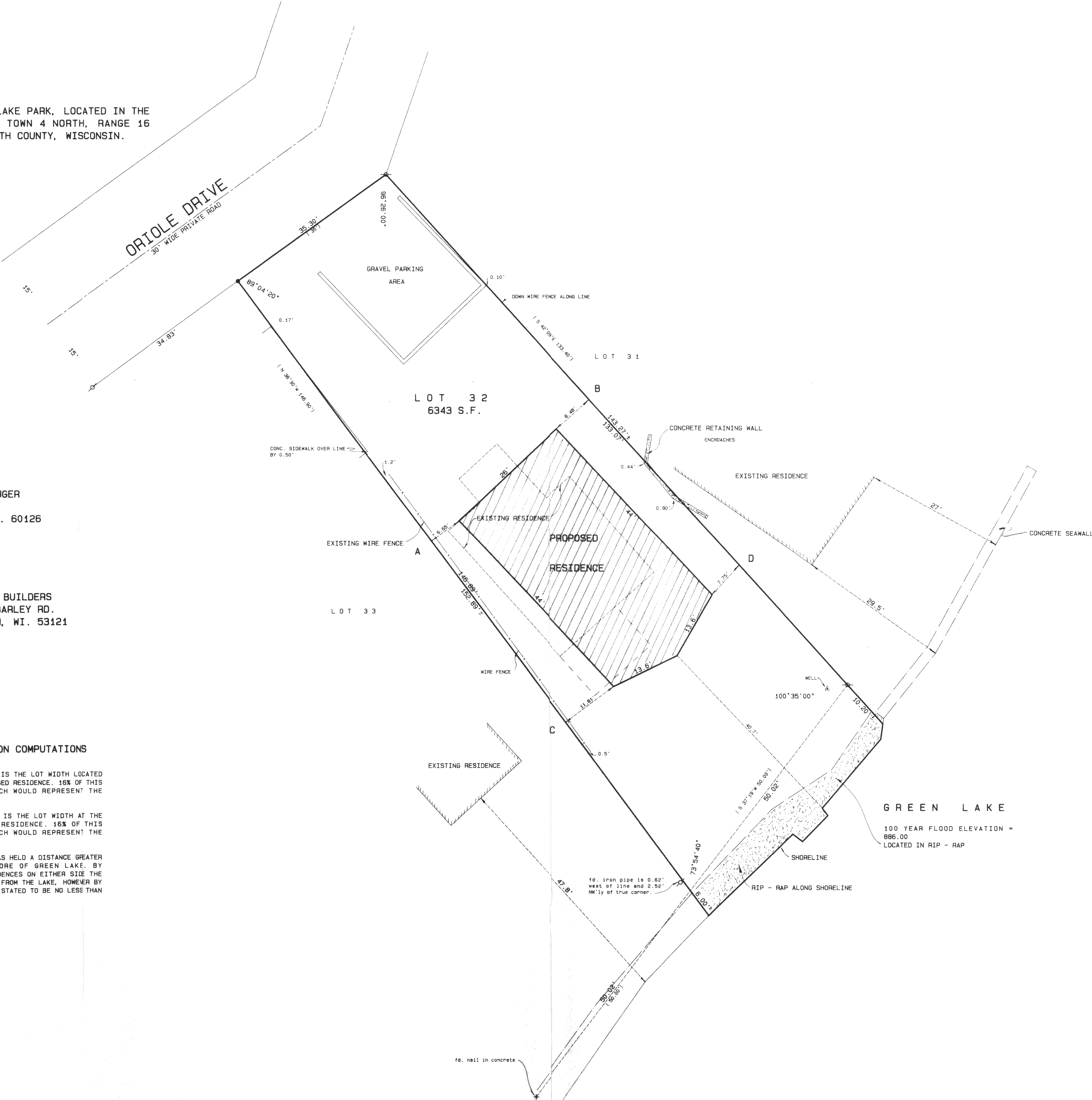

BUILDING LOCATION COMPUTATIONS

LINE A - B = 41.09' AND IS THE LOT WIDTH LOCATED
AT THE REAR OF THE PROPOSED RESIDENCE. 16% OF THIS
DIMENSION = 6.57' WHICH WOULD REPRESENT THE
MINIMUM SIDEYARD SETBACK.

LINE C - D = 45.29' AND IS THE LOT WIDTH AT THE
FRONT OF THE PROPOSED RESIDENCE. 16% OF THIS
DIMENSION = 7.25' WHICH WOULD REPRESENT THE
MINIMUM SIDEYARD SETBACK.

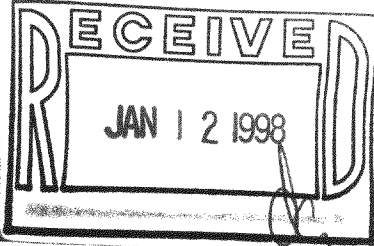
THE PROPOSED RESIDENCE WAS HELD A DISTANCE GREATER
THAN 40' FROM THE SHORE OF GREEN LAKE. BY
AVERAGING WITH THE RESIDENCES ON EITHER SIDE THE
RESIDENCE COULD BE 37.4' FROM THE LAKE, HOWEVER BY
ORDINANCE THE MINIMUM IS STATED TO BE NO LESS THAN
40'.



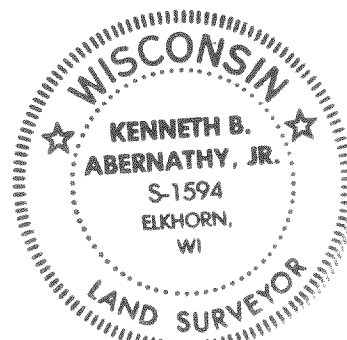
