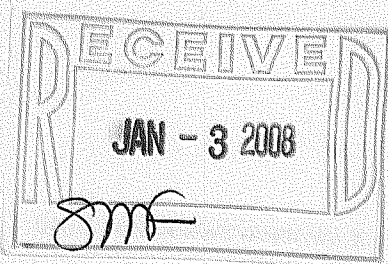

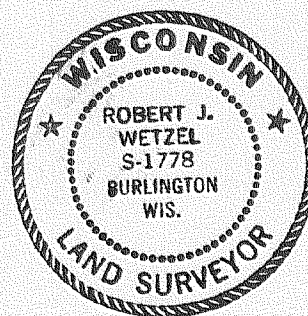

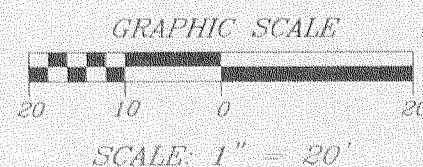


LEGEND

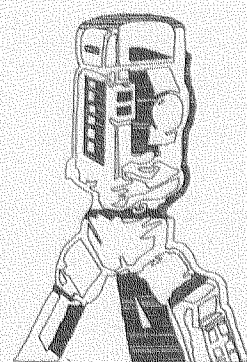
