

PLAT OF SURVEY

PART OF BLOCK 1 OF CARSWELL PARK

BEING A PART OF SECTION 35, TOWN 4 NORTH, RANGE 16 EAST,
TOWN OF LAGRANGE, WALWORTH COUNTY, WISCONSIN

3. The land referred to in the Commitment is described as follows:
Part of Block 1 of Carswells Park described as follows:
Situating in the Town of LaGrange, County of Walworth and State of Wisconsin:
Commencing at an iron stake, said stake being located 270 feet E following along the shore of Mill Lake from the SW corner of Lot 1 Block 1 of Carswells Park, thence N'ly following along the shore 100 feet to an iron stake, thence NW'ly 125 feet to an iron stake which is 20 feet from the NE corner of the above described parcel of land and on a line with the same NW'ly 55 feet to an iron stake, thence following along the shore of pond W'ly 50 feet to an iron stake; thence SE'ly 72 feet to an iron stake; thence NE'ly 56 feet to place of beginning. All of the above being in Block 1 of Carswells Park and being a portion of Section 35, T4N of R16E.
Commencing at an iron stake, said stake being located 370 feet from the SW corner of Block 1 of Carswells Park measured along the shore of Mill Lake E'ly 270 feet, thence N'ly 100 feet to said located stake; thence W'ly 50 feet to an iron stake; thence W'ly 96 feet to an iron stake; thence S'ly 30 feet to an iron stake; thence E'ly 125 feet to place of beginning.
ALSO the following described parcel of land lying W'ly across a 20 foot roadway, commencing at an iron stake 20 feet from the NW corner of the first described parcel of land; thence W'ly 36 feet to an iron stake; thence S'ly 25 feet to a stake; thence E'ly 55 feet to a stake which is 20 feet W'ly from the SW corner of the first described parcel of land; thence N'ly 27 feet to the place of beginning.

A parcel of land located in the Block 1 of Carswells Park and being a portion of Section 35, T4N, R16E, Walworth County, Wisconsin, described as follows, to-wit:
Beginning at a point located 420 feet measured along the shore of Mill Lake from the Southwest corner of Lot 1 Block 1 of Carswells Park, thence North 55° 44' 30" West along the Northerly line of land owned by William R. and Margaret C. Sellers 96.0 feet; thence South 32° 30' West 20.60 feet along the roadway; thence South 65° 24' East 12.89 feet; thence North 49° 05' East 4.67 feet; thence South 65° 24' East 82.45 feet to the place of beginning.

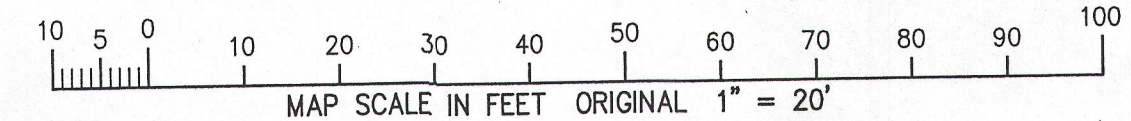
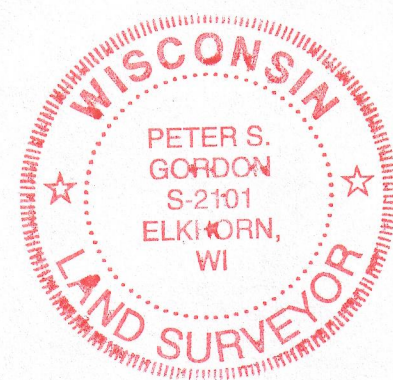
