All that certain piece of parcel of land lying and being in the plat of Oak Park, which plat is on record

in the Register of Deeds office in and for Walworth County, Wisconsin, in vol. 6 of plats, on page 18, and being all of lot 17 and that part of lot 16, described as follows, to-wit: Being that part of lot 16 lying W'ly of a line drawn from the S.W'ly corner of said lot 16 and passing through a stake on the base line of said plat, 27 ft. N.E'ly of the point of intersecting of said base line with the W'ly line of said lot 16, and continuing on said line (from the N.E'ly corner of said lot 16 to the stake of the said base line) to the shore of Middle Lake at low water line, thence W'ly along the shore of said lake at low water line to the S.W'ly corner of said lot 16, thence N.W'ly on the W'ly line of said lot 16 to the place of beginning. 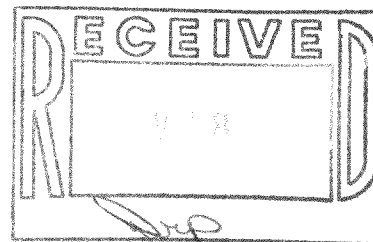
