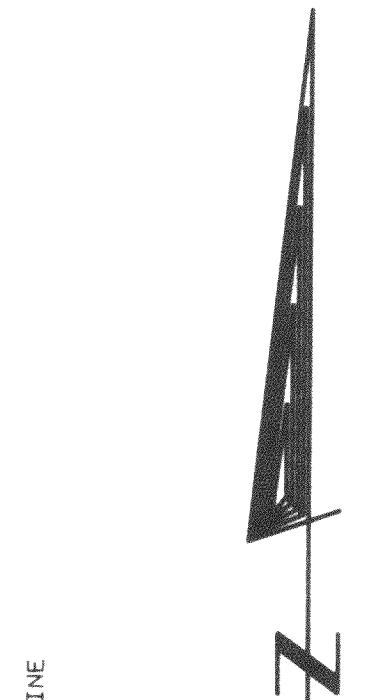
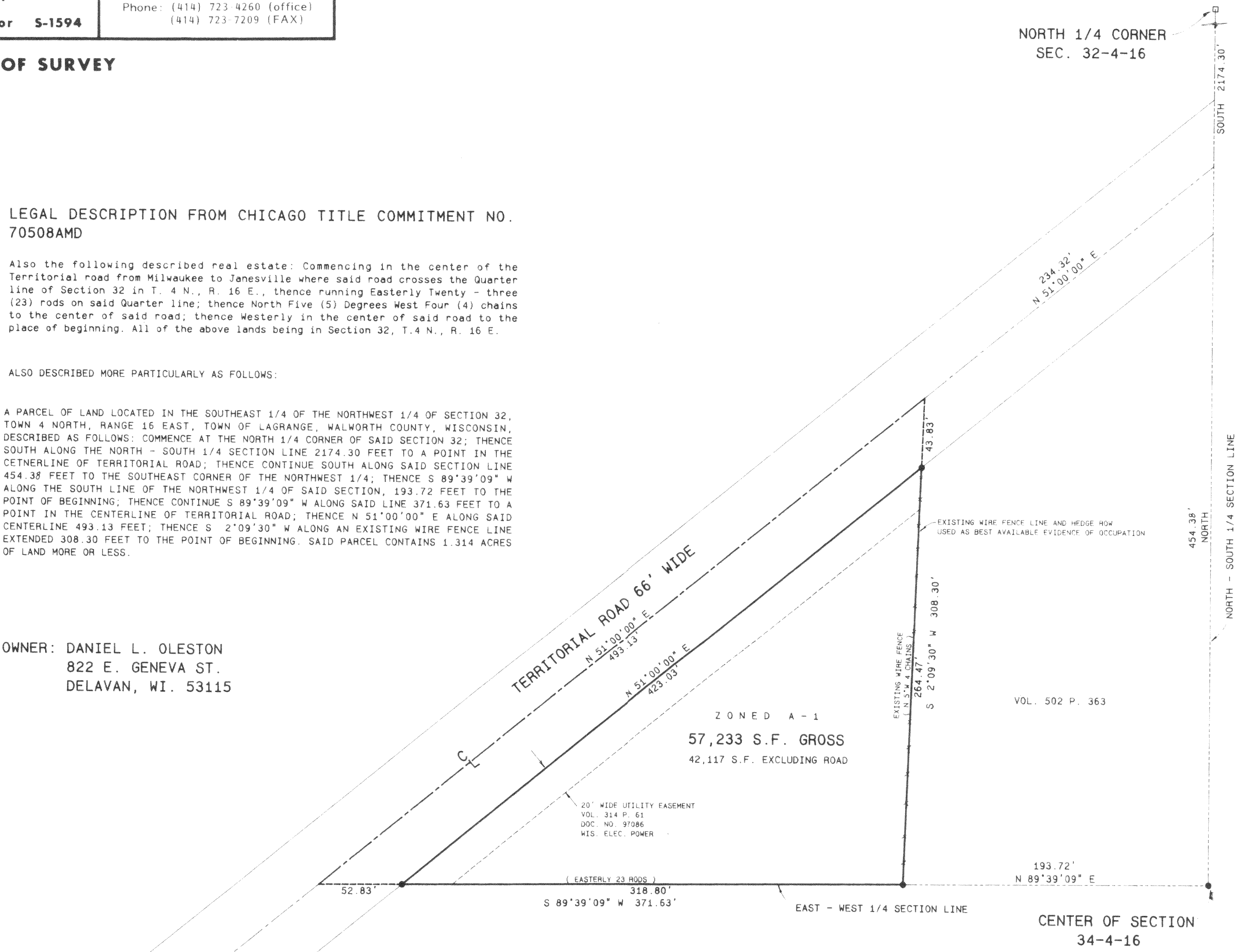
LEGAL DESCRIPTION FROM CHICAGO TITLE COMMITMENT NO. 70508AMD

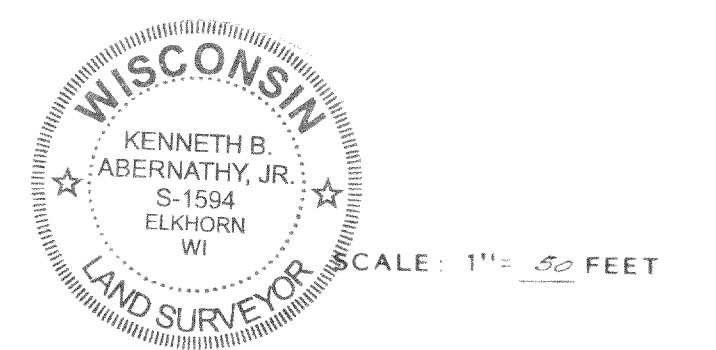
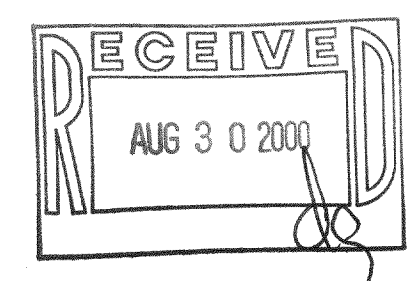
