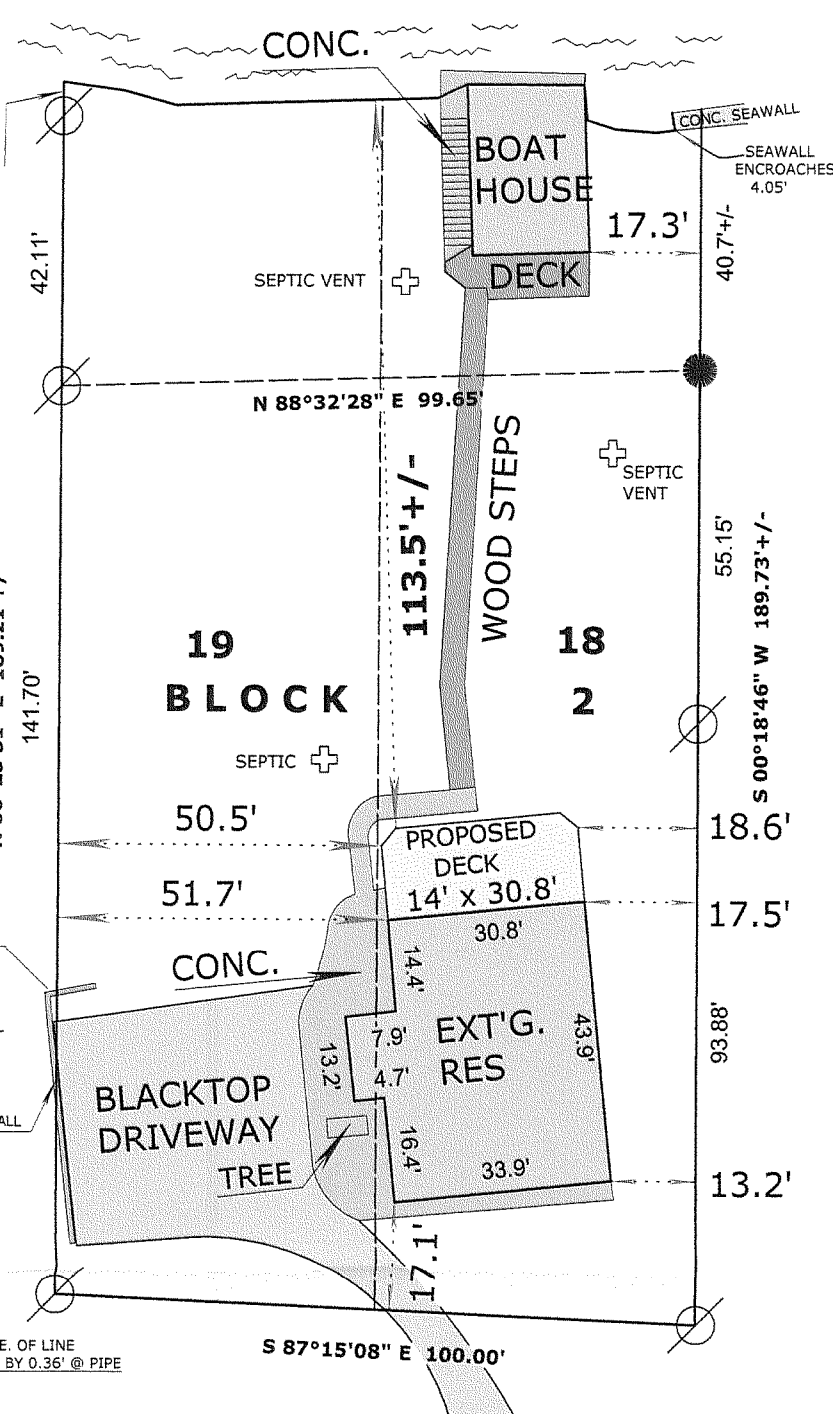
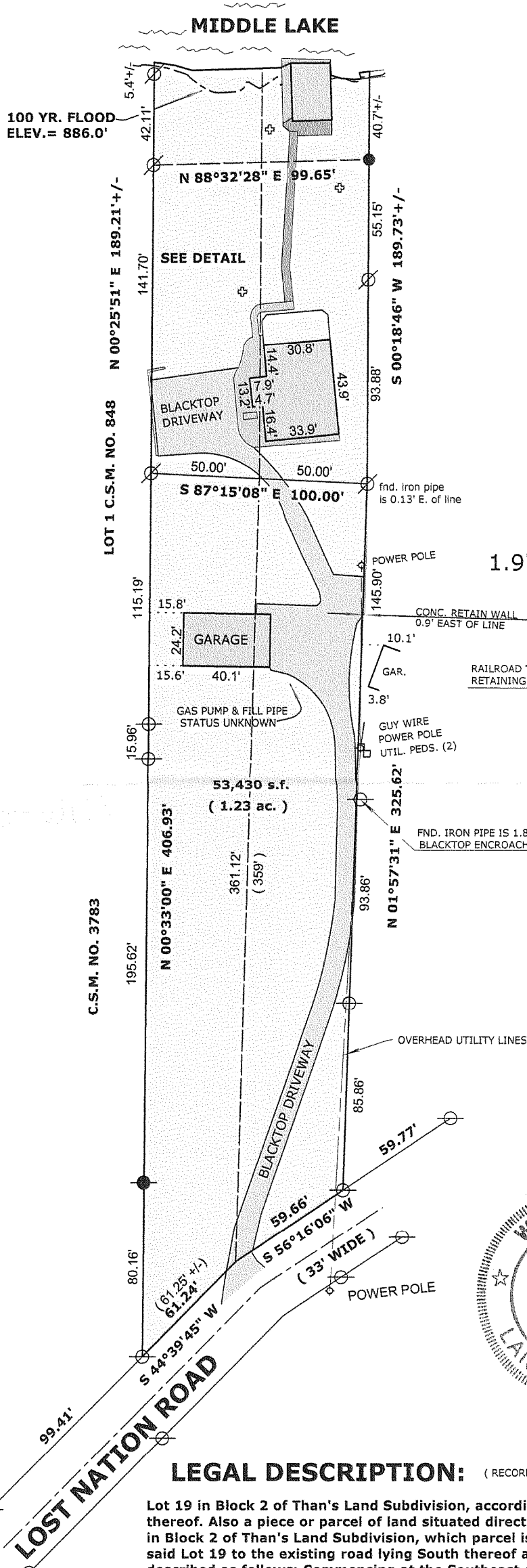

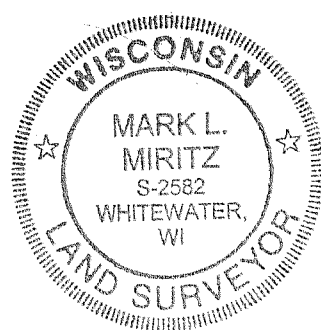

LEGAL DESCRIPTION: (RECORDED IN VOL. 554 P. 927)

Lot 19 in Block 2 of Than's Land Subdivision, according to the recorded plat thereof. Also a piece or parcel of land situated directly South of Lot 19 in Block 2 of Than's Land Subdivision, which parcel is a continuation of said Lot 19 to the existing road lying South thereof and is more particularly described as follows: Commencing at the Southeast corner of said Lot 19; running South 359 feet to an iron stake; thence Southwesterly 61.25 feet more or less along the North side of the existing road to an iron stake; thence Northerly to the southwest corner of said Lot 19; thence East along the South line of said Lot 19 to the place of beginning. Lot 18 in Block 2 of Than's Land Subdivision, according to the recorded plat thereof. Also a parcel of land situated directly South of Lot 18 described as follows: The West 50 feet of the following: Commencing at the Southeast corner of Lot 16 of said block; thence West 145 feet to the Southwest corner of Lot 18; thence South parallel with the North and South 1/4 section line 359 feet to an iron stake; thence Northeasterly 179 feet to an iron stake; thence North parallel with the North and South 1/4 section line to the place of beginning.
