 Range 16 East, Town of LaGrange, Walworth County, Wisconsin.

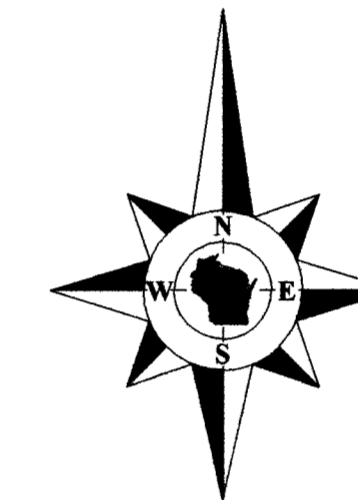
A parcel of land described in Title Commitment No. WA-1196 prepared by Chicago Title Insurance Company, dated October 31, 2013, as shown below:

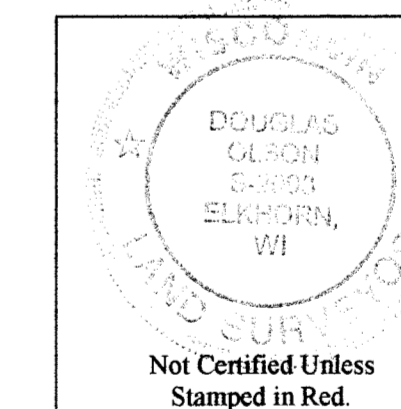
Also commencing at a point on the Westerly line of Lot 1 of said Subdivision, which point is located 5.24 feet Northerly of the Southwest corner of said lot; thence N. 81° - 21' E, 35.23 feet to a point; thence S 61° - 05' E 40.54 feet to the place of beginning; thence S 28° - 40' E 21.73 feet to the shore of Middle Lake; thence Northeasterly along the shore 39.5 feet to a private road; thence S 81° - 33' W 41.78 feet along said road to the place of beginning.
