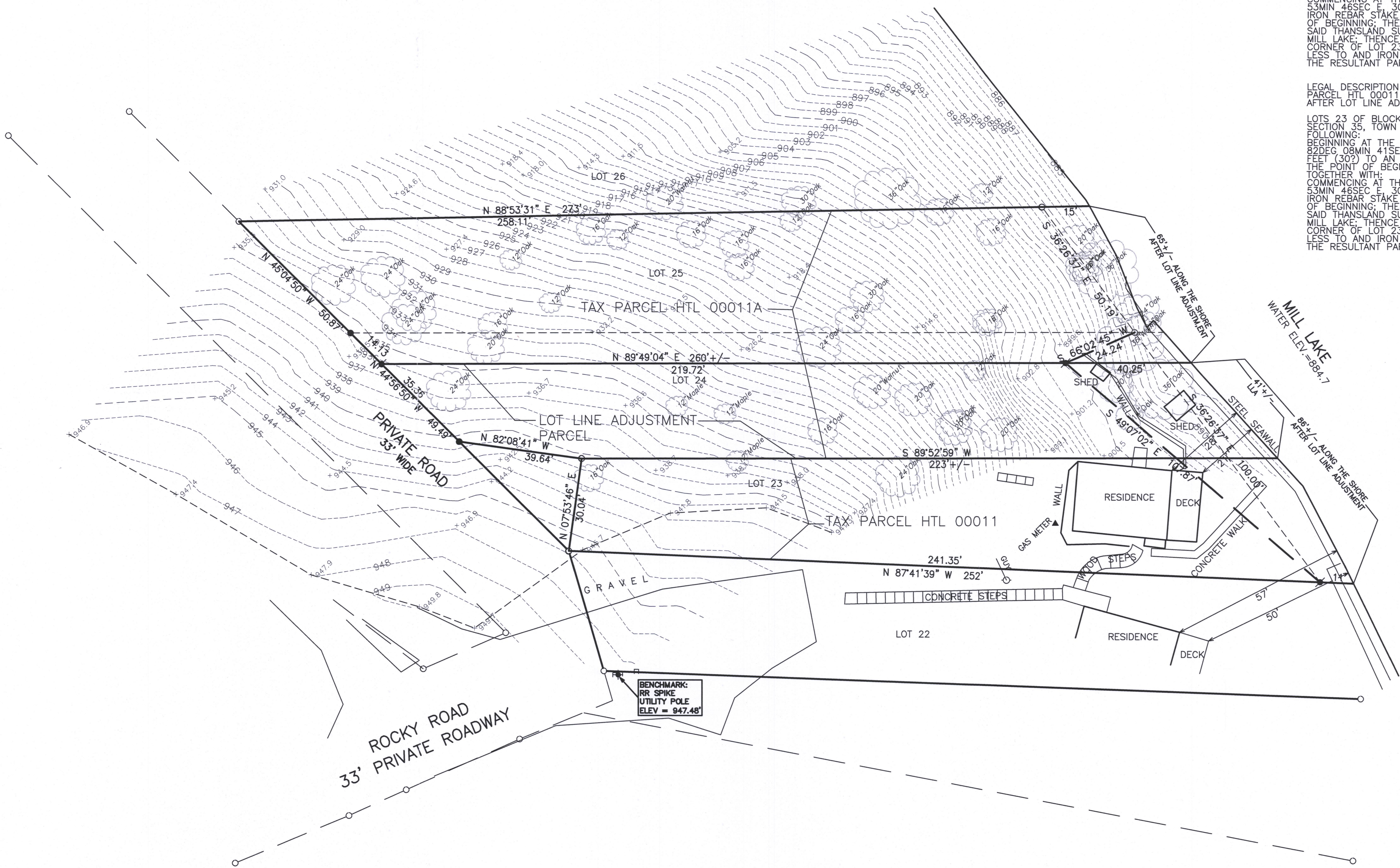
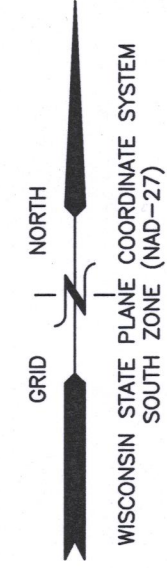


PLAT OF SURVEY & TOPOGRAPHIC MAPPING

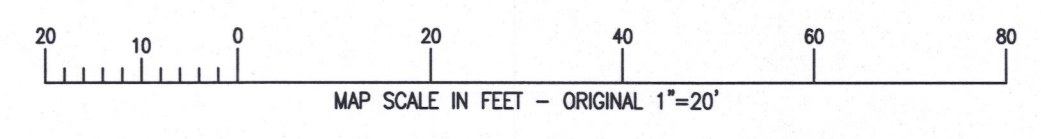

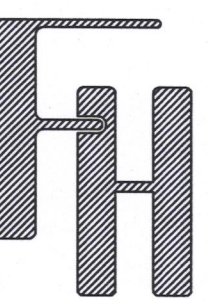
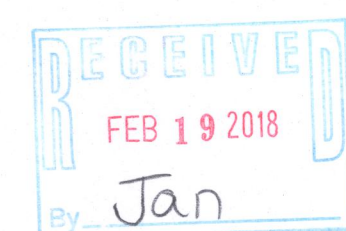
