DESCRIBED AS FOLLOWS: Commencing at an iron pipe at the SW Corner of said Lot 12; thence N1°26'31"W along the West Line of said Lot 12, a distance of 167.67 feet to an iron pin at the place of beginning for the land to be herein described; thence S86°44'49"W 0.86 feet to an iron pin; thence N0°54'41"W 26.82 feet to an iron pin at meander corner no.1 thence N1°49'42"E 7.1 feet, more or less to the water's edge of Middle Lake; thence Easterly along said water's edge, 0.2 feet, more or less to said West Line; thence S1°26'31"E along said West line, 5.5 feet, more or less to an iron pin at meander corner no.2; (meander corner no. 2 is located S16°18'E 2.40 feet from meander corner no.1); thence S1°26'31"E continuing along said West Line, 24.47 feet to the place of beginning.
