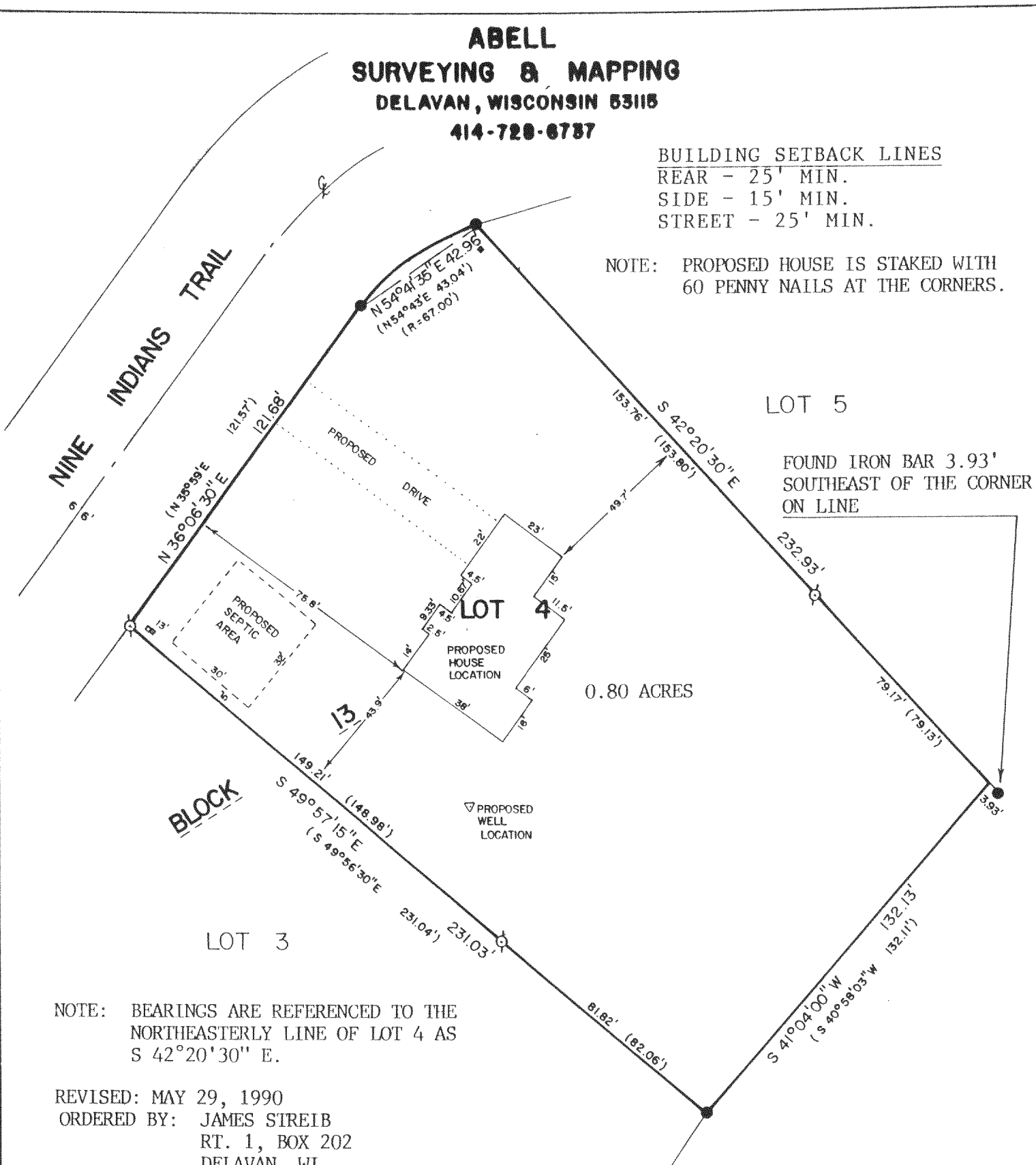

 60 PENNY NAILS AT THE CORNERS.



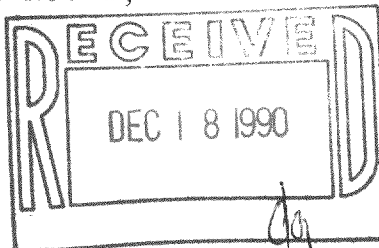
