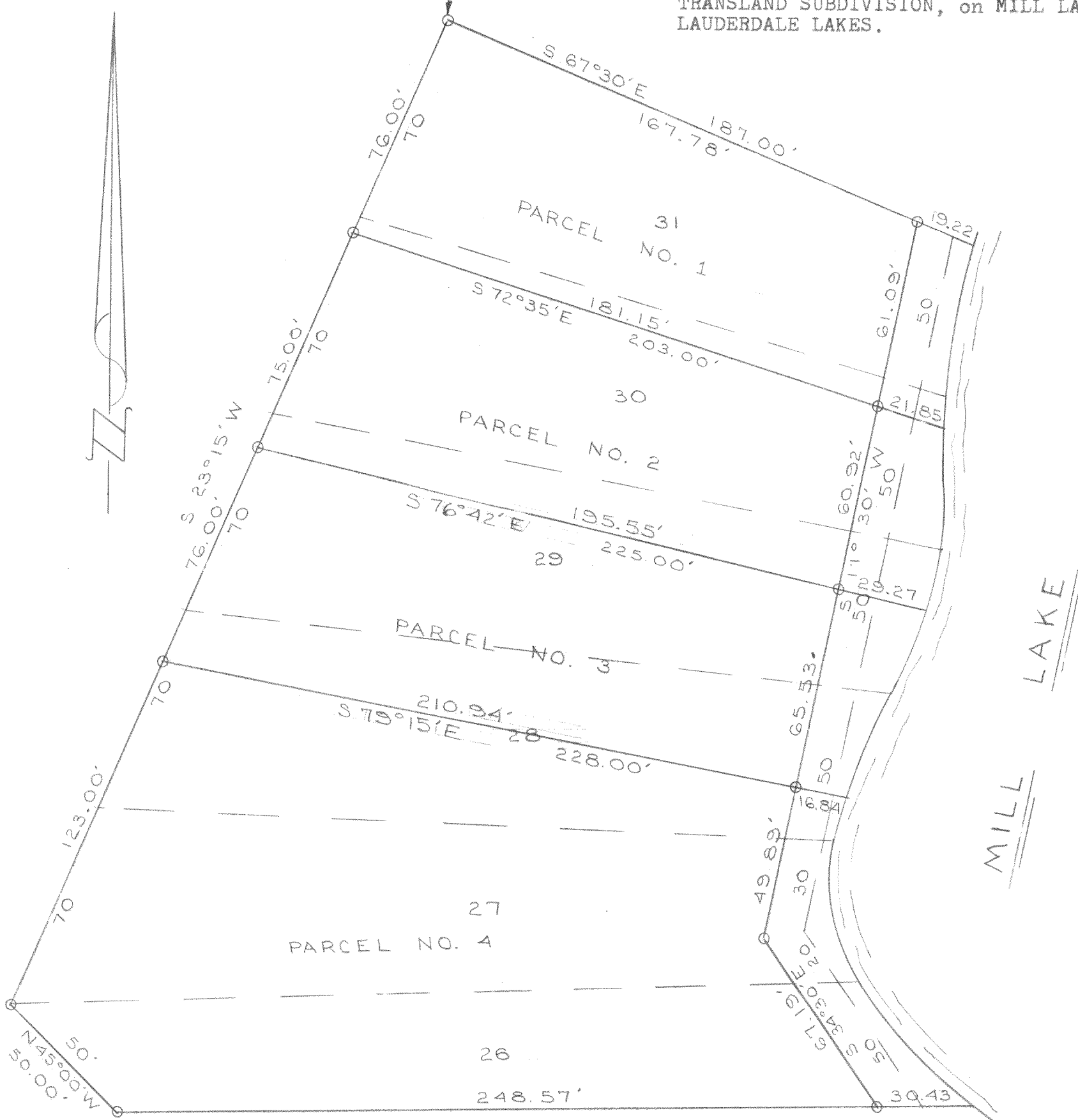


SW CORNER LOT 32, BLK 1,

DESCRIPTION:

Parcel No. 1 Commencing at the SW corner of Lot 32, Block 1, Transland Subdivision, Walworth County, Wisconsin, thence S 67°30' E along the south line of said Lot 32, 167.78 feet to a point, thence continue S 67°30' E along said south line of said Lot 32, 19.22 feet to the shore of Mill Lake, thence S'ly along said shore, 60 feet more or less, thence N 72°35' W, 21.85 feet to a point, said point being S 11°30' W, 61.09 feet thence continue N 72°35' W, 181.15 feet to the west line of said Block 1, thence N 23°15' E, 76.00 feet to the place of beginning.

Parcel No. 2 Commencing at said SW corner of said Lot 32, Block 1, thence S 23°15' W along the west line of said Block 1, 76.00 feet to the place of beginning, thence S 72°35' E, 181.15 feet to a point, thence continue S 72°35' E, 21.85 feet to the shore of Mill Lake, thence S'ly along said shore, 60 feet more or less thence N 76°42' W, 29.27 feet to a point, said point being S 11°30' W, 60.92 feet from the aforementioned point, thence continue N 76°42' W, 195.55 feet to said west line of said Block 1, thence N 23°15' E along said west line of said Block 1, 76.00 feet to the place of beginning.

Parcel No. 3 Commencing at said SW corner of said Lot 32, Block 1, thence S 23°15' W along the west line of said Block 1, 151.00 feet to the place of beginning, thence S 76°42' E, 195.55 feet to a point, thence continue S 76°42' E, 29.27 feet to the shore of Mill Lake, thence S'ly along said shore 65 feet more or less, thence N 79°15' W, 16.84 feet to a point, said point being S 11°30' W, 65.53 feet from the aforementioned point, thence continue N 79°15' W, 210.94 feet to said west line of said Block 1, thence N 23°15' E along said west line of said Block 1, 76.00 feet to the place of beginning.

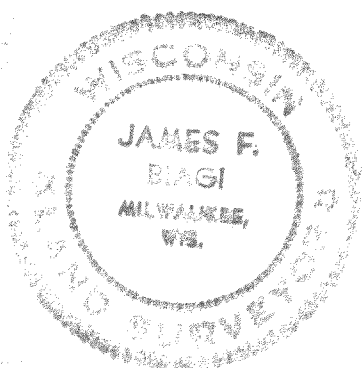

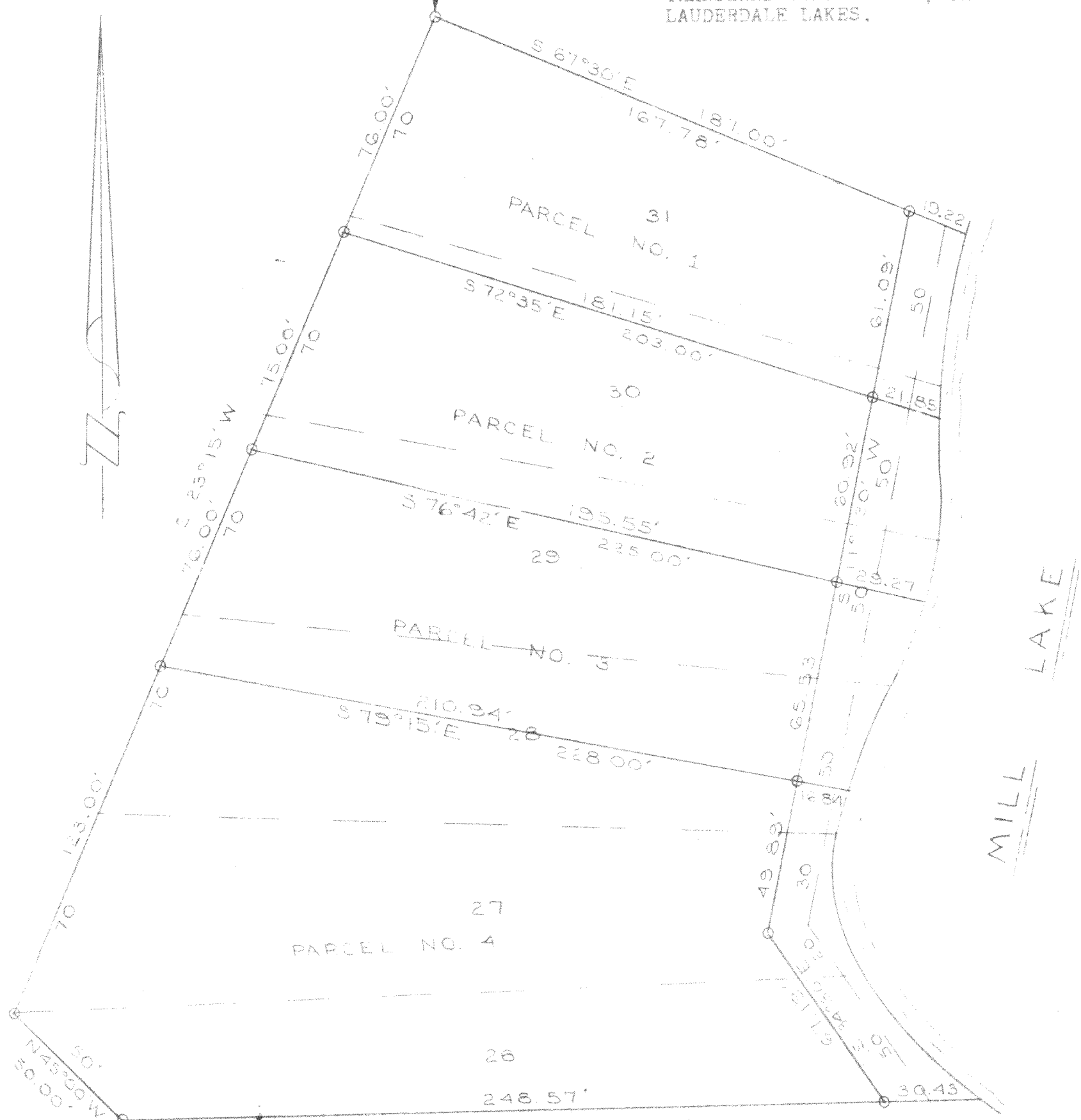

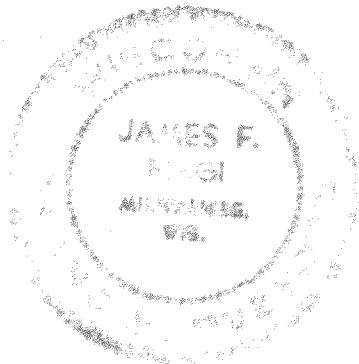
