

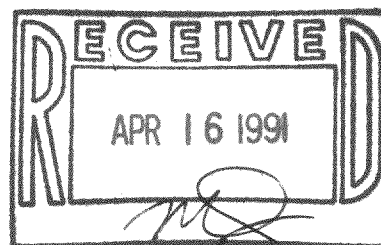
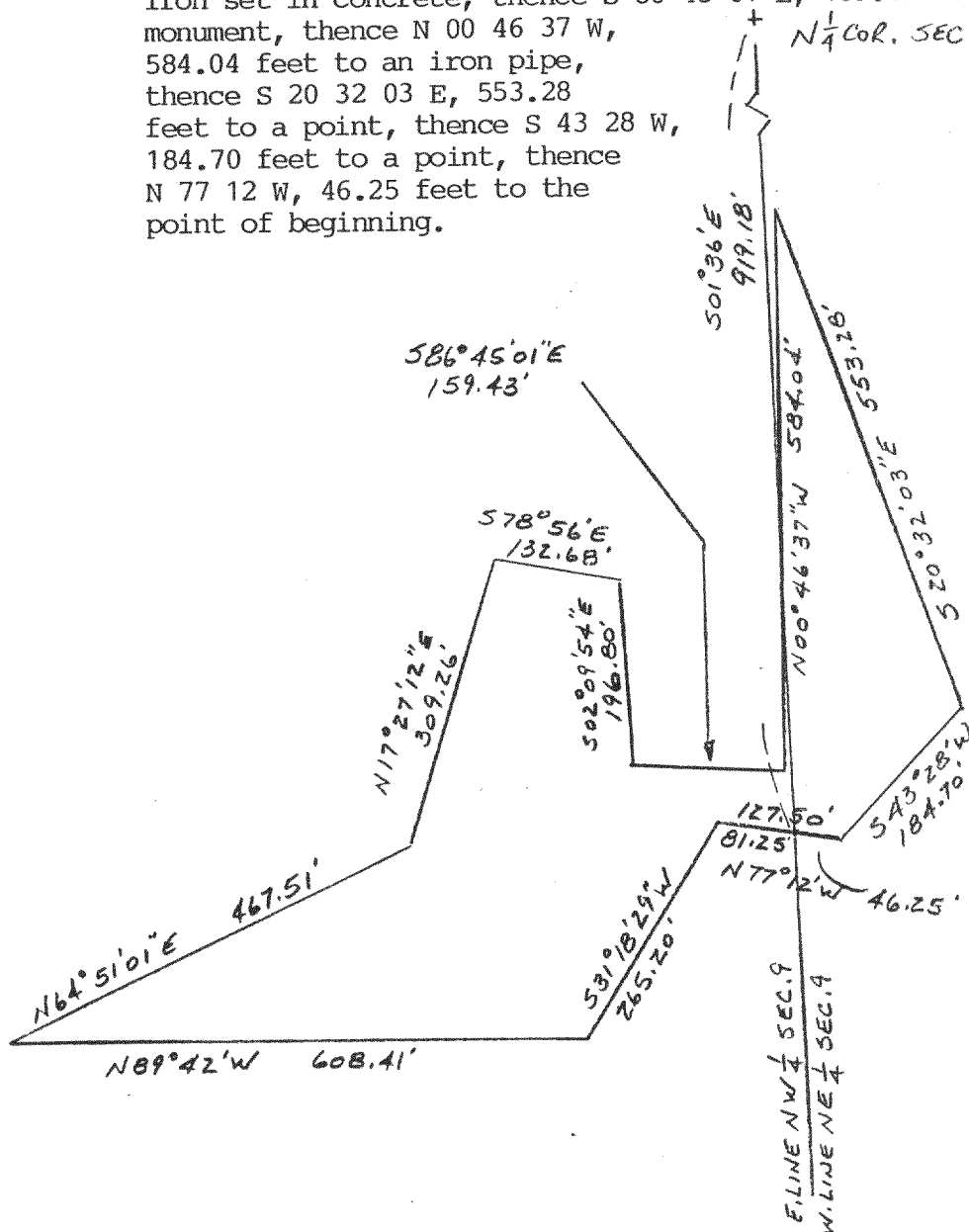
# PLAT OF SURVEY

**DESCRIPTION:** Parcel 2 of Unrecorded Plat of Timber Lake, recorded in Volume 245 of Records on page 277 as Document No. 54337, described as follows: That part of the NE $\frac{1}{4}$  and the NW $\frac{1}{4}$  of Section 9, T4N, R17E, in the Town of Troy, Walworth County, Wisconsin, bounded and described as follows: Commencing at the North  $\frac{1}{4}$  corner of said Section 9; thence S 01 36 E, along the East line of said NW $\frac{1}{4}$  Section, 919.18 feet to the point of beginning; thence N 77 12 W, 81.25 feet to a point, thence S 31 38 29 W, 265.20 feet to a point, thence N 89 42 W, 608.41 feet to a point, thence N 64 51 01 E, 467.51 feet to an angle iron set in concrete, thence N 17 27 12 E, 309.26 feet to an angle iron set in concrete, thence S 78 56 E, 132.68 feet to an angle iron set in concrete, thence S 02 09 54 E, 196.80 feet to an angle iron set in concrete, thence S 86 45 01 E, 159.43 feet to a concrete monument, thence N 00 46 37 W, 584.04 feet to an iron pipe, thence S 20 32 03 E, 553.28 feet to a point, thence S 43 28 W, 184.70 feet to a point, thence N 77 12 W, 46.25 feet to the point of beginning.

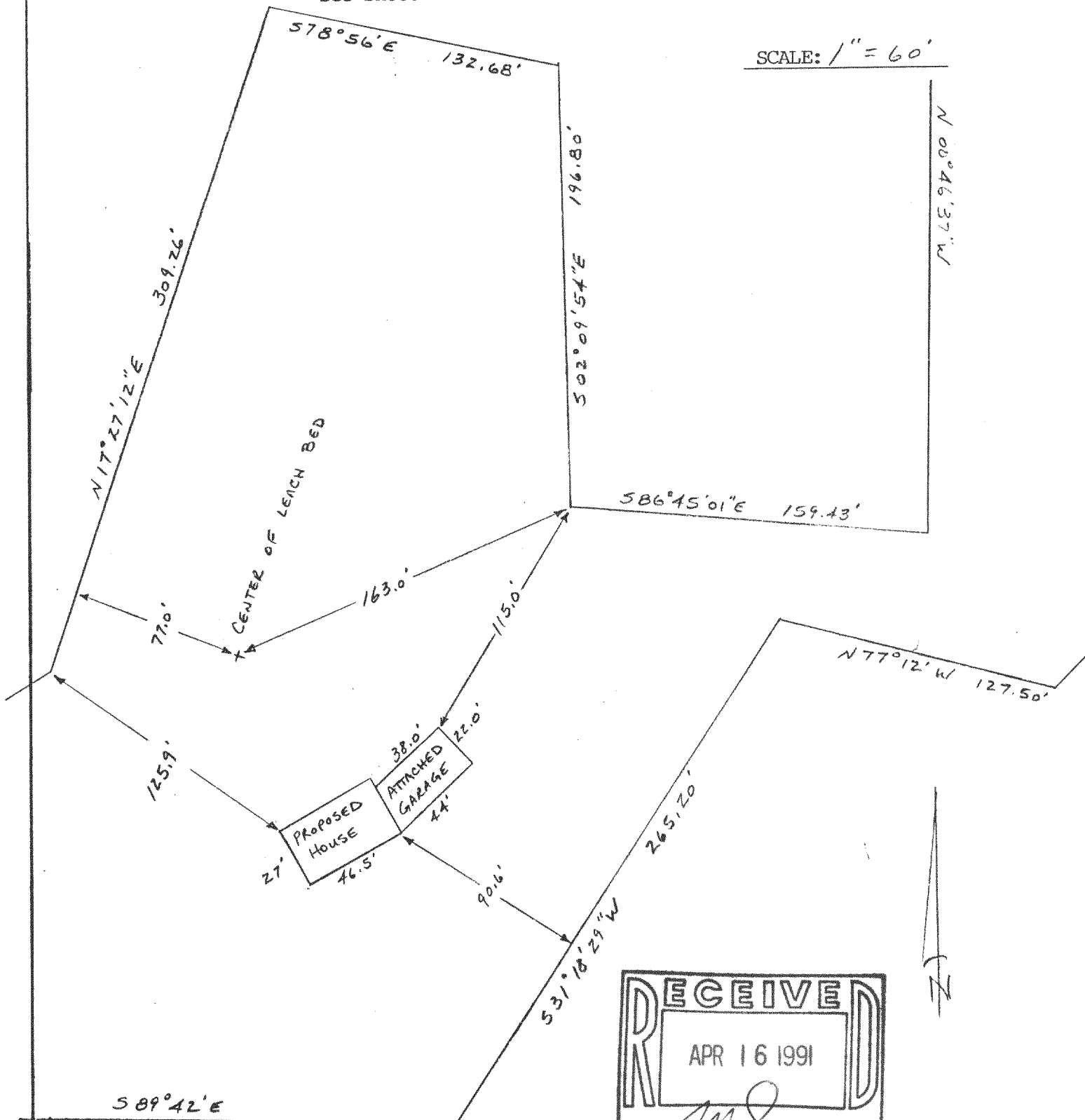
