





**PLAT OF SURVEY OF**

Commencing at the east quarter corner of Section 12, Town 4 North, Range 17 East, thence North 89°38'11" West, along the east quarter line of Section 12, 180.00 feet to the point of beginning; thence South 0°34'20" West, 830.34 feet to a point on the northerly right-of-way line of Otto Court; thence Westerly along said Northerly right-of-way line, the arc of 332.02 feet, the radius of 1167.00 feet, the central angle of 16°18'04" and the center of which is in a Northerly direction, the chord of which bears North 74°02'30" West, 330.90 feet; thence Westerly along said Northerly right-of-way line, the arc of 25.02 feet, the radius of 2033.00 feet, the central angle of 0°42'18" and the center of which is in a Southerly direction, the chord of which bears North 66°14'37" W., 25.02 feet; thence North 0°34'20" East, 731.45 feet to a point on the east quarter line of Section 12; thence South 89°38'11" East, along the east quarter line of Section 12, 342.04 feet to the point of beginning.
