All that part of **LOT 32, BLOCK 22, MIRAMAR ADDITION NO. 1**, being a Subdivision of part of the Northwest  $\frac{1}{4}$  and part of the Southwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 10, Town 4 North, Range 18 East, Town of East Troy, Walworth County, Wisconsin, described as follows: Commencing at the Southeast corner of the Northeast  $\frac{1}{4}$  of said Section 10; thence North  $89^{\circ}51'49''$  West along the South line of the Northeast  $\frac{1}{4}$  of said Section 10, 1979.31 feet; thence North  $41^{\circ}04'02''$  East, 23.75 feet to the South corner of said Lot 32 and the Point of beginning; thence North  $00^{\circ}16'07''$  West along the West line of said Lot 32, 48.06 feet; thence South  $89^{\circ}51'49''$  East, parallel to the South line of the Northeast  $\frac{1}{4}$  of said Section 10, 43.12 feet to the Southeasterly line of said Lot 32; thence South  $41^{\circ}48'55''$  West along said Southeasterly line, 64.34 feet to the Point of beginning, containing 1036 sq. ft. of land.
