

A parcel of land located in the Southwest fractional 1/4 of Section 11, T4N, R14E, of Walworth County, Wisconsin described as follow, to-wit: Commencing at the West 1/4 Section corner of said section; thence South 178.10 feet; thence N75°38'18" 79.89 feet; thence N86°16'12" 139.32 feet; thence N60°30'18" 170.90 feet; thence S52°19'18" 257.08 feet; thence N36°31'18" 551.66 feet to the centerline of a Public Road; thence S33°12'18" along the centerline 1531.05 feet; thence S89°10'18" 55.57 feet to an iron pipe located South of a tree, which tree is mentioned in deed conveying land in this area; thence N7°23'18" along the West line of land formerly owned by Arthur Healey 180.00 feet to the point of beginning; thence continue S7°23'18" along said line 192.34 feet to the centerline of a ditch; thence S74°37'18" along said centerline 79.00 feet; thence continue along said ditch S62°07'18" 36.11 feet; thence N69°33'18" 135.85 feet; thence N27°34'18" 61.69 feet; thence N2°17'18" 104.99 feet; thence N67°54'18" 91.06 feet to the point of beginning, together with an easement and right for the benefit of Emma Schmidt, her heirs and assigns and their guests to walk over premises conveyed by deed to Ray L. 
