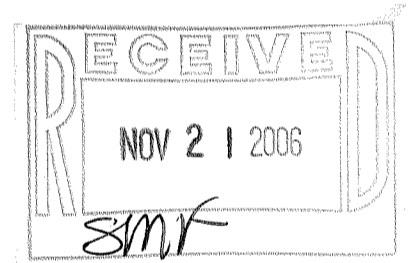


PLAT OF SURVEY

LOT 6, THE NORTH 1/2 OF LOT 7 AND PART OF LOT 5 (SHOWN HEREIN AS PARCEL A), ALL IN BLOCK 2, FREES PARK, a Subdivision located in the Southeast 1/4 of Section 4, Town 4 North, Range 18 East of the 4th P.M. Township of East Troy, Walworth County, Wisconsin.

Description of Parcel "A": Part of Lot 5, Block 2, Frees Park, a plat of record in Section 4, Town 4 North, Range 18 East, and more particularly described as follows: Commence at the Southeast corner of said Lot 5, being a point in the center of East Shore Road; thence North 6° 37' 30" West (recorded as North 6° 30' West), along said center line, 13.51 feet; thence South 62° 08' 45" West, 24.66 feet to a reference point; thence continue South 62° 08' 45" West, 10.74 feet to an iron pipe stake; thence continue South 62° 08' 45" West, 81.51 feet to an iron pipe stake; thence continue South 62° 08' 45" West, 2.5 feet, more or less, to the water's edge of Lake Beulah; thence Southerly along the water's edge of Lake Beulah to the South line of Lot 5; thence North 65° 30' East, along the South line of Lot 5, 116.54 feet, more or less, to the place of beginning. Containing 1097 square feet of land, more or less. Subject to the rights of the public over the East side for highway purposes. Containing 687 square feet of land, more or less, and exclusive of highway. Said land is located in the Township of East Troy, Walworth County, Wisconsin.

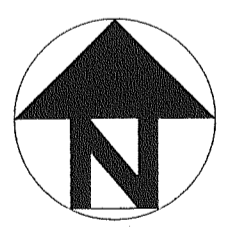
