Described in Two Deeds as Follows

Commencing at a stake at the South East corner of lot of R. L. Porter and E. Cripe, same being S. 40 $\frac{1}{2}$ ° E. 2.47 chains from center of fractional Section 9, Town 4 North, Range 18 East; thence N. 86 $\frac{1}{2}$ ° E. 3.60 chains to a stake; thence N. 25 $\frac{1}{2}$ ° W. 4.45 chains to the shore of Lake Beulah; thence SW'ly along the lake 1.58 chains to N.E. corner of lot of Porter and Cripe; thence S. 4.30 chains to place of beginning. Known as lot one.

ALSO

Commencing at S.E. corner of said lot one; thence N. 86 $\frac{1}{2}$ ° E. 1.79 chains; thence N. 31° E. 1.1 $\frac{1}{2}$ chains; thence N. 37° W. 5.49 chains to the shore of Lake Beulah; thence SW'ly along the shore of Lake Beulah to N.E. corner of said lot one 1.58 chains to place of beginning; known as lot two.

Lot 3 described as follows:

Commencing at the S.E. corner of lot 2, in fractional section 9, Town 4 North, Range 18 East; thence to E. R. Case; thence N. 31° E. 3 chains; thence N. 51 $\frac{3}{4}$ ° W. 5 chains to the lake shore at a white oak tree 4" in diameter; thence SW'ly along the lake shore 1.58 chs. to the NE corner of lot 2 owned E. R. Case; thence S. 37° E. 5.49 chs. to place of beginning. Contains 1.17 acres more or less.

We, the undersigned, Emil Goedtko Jr. owner of that part of lot 3 lying East and adjoining lot 2 owned by Charles A.V. Standish hereby agree to build a party fence on the line between said lots 2 and lot 3 as shown on the plat hereon drawn. Said lots being described in Warranty Deeds from Edward Shepard to his grantees and from said grantees and their successors and assigns to us. This agreement is made for the purpose of correctly establishing the line between lots 2 and 3 and said fence having been built we have each paid one-half the cost thereof.
