

# Plat of Survey

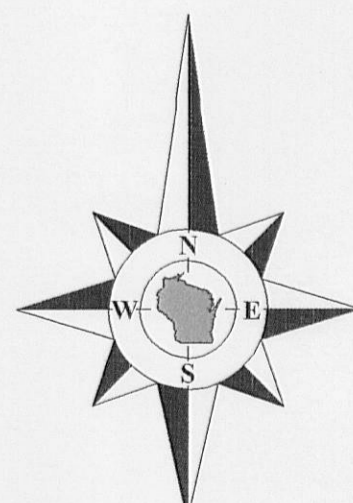
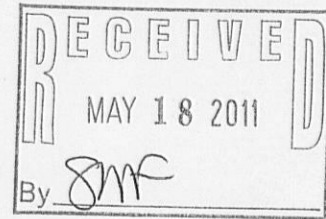

## Proposed Lot Line Adjustment from Tax Parcel PA165100004A1 to Tax Parcel PA 97900001

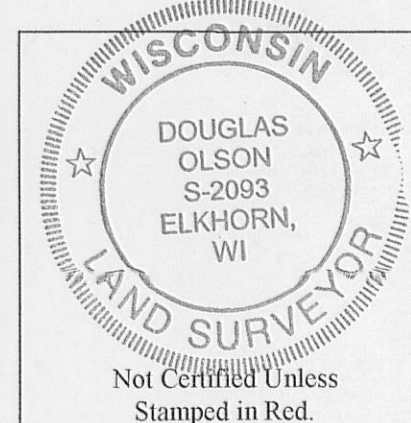
Part of Lot 4 of Certified Survey Map No. 1651, located in the Northwest 1/4 of Section 8, Town 4 North, Range 18 East, Town of East Troy, Walworth County, Wisconsin, described as follows: Begin at an iron rod at the Southwest corner of said Lot 4; thence North 2°34'01" East, along the West line of said Lot 4, 143.44 feet to an iron rod; thence South 0°26'53" East 143.47 feet to an iron pipe at the Northeast corner of Lot 1 of Certified Survey Map No. 979; thence North 88°42'00" West, along the South line of said Lot 4 of Certified Survey Map No. 1651, also being the North line of said Lot 1 of Certified Survey Map No. 979, 7.55 feet to the Point of Beginning.

Said parcel contains 0.012 acre (541 sq. ft.) of land, more or less, and is a lot line adjustment from Tax Parcel PA165100004A1 to Tax Parcel PA 97900001.

This lot line adjustment is for the purpose of a sale or exchange between adjoining land owners that does not create additional lots and the original parcels are not reduced below the minimum size required by the Walworth County Code of Ordinances (Zoning/Shoreland Zoning).
