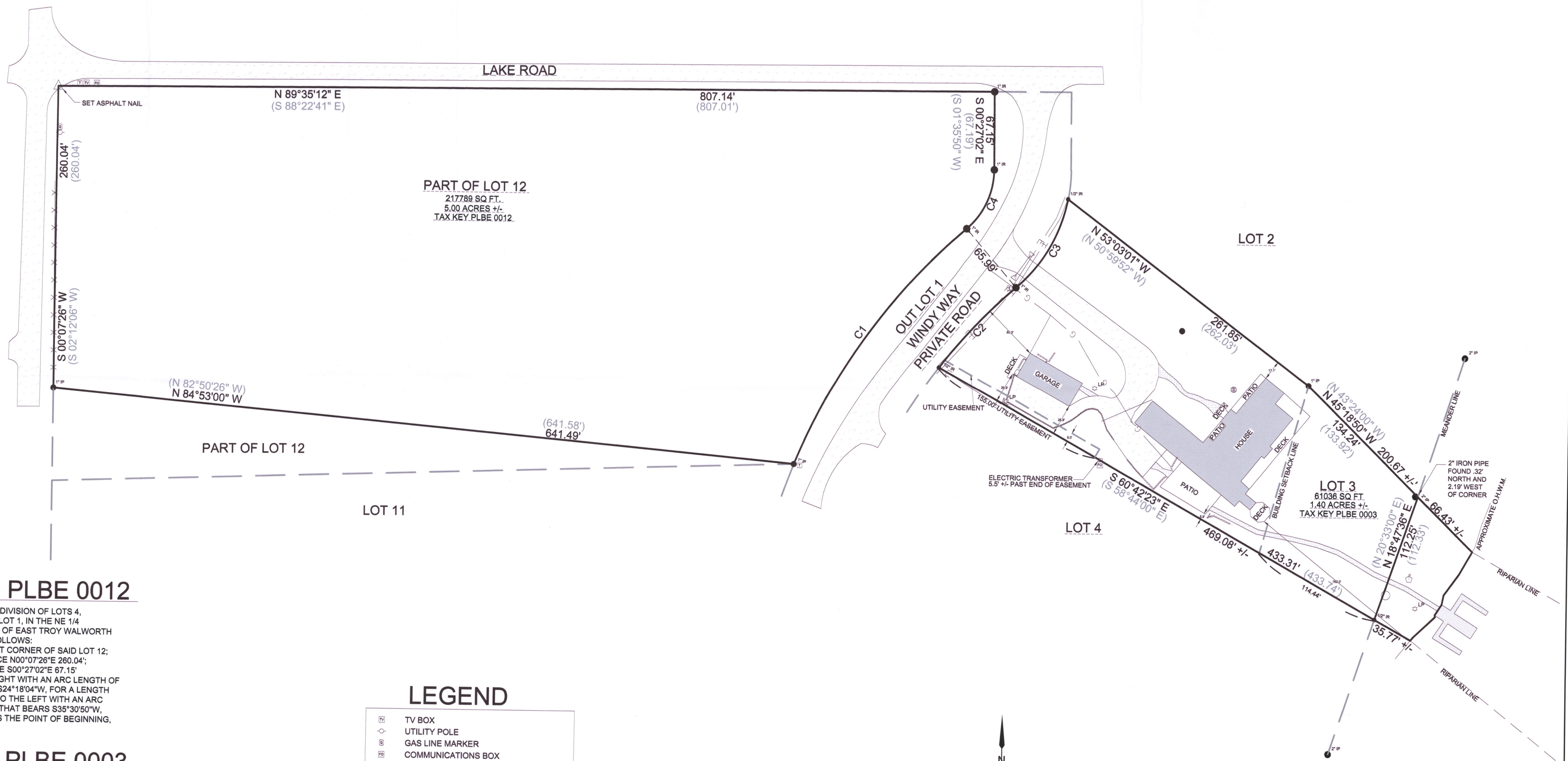

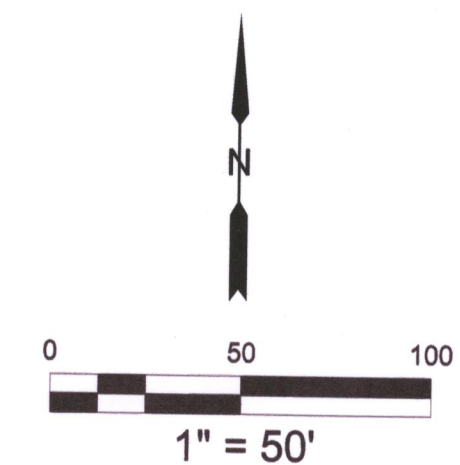
BEING A PART OF LOT 12 OF LAKE BEULAH ESTATES BEING A DIVISION OF LOTS 4, 5 AND PART OF 3 IN STEVENS SUBDIVISION IN GOVERNMENT LOT 1, IN THE NE 1/4 OF SECTION 8 TOWN 4 NORTH, RANGE 18 EAST, IN THE TOWN OF EAST TROY WALWORTH COUNTY WISCONSIN MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT 1" FOUND IRON PIPE MARKING THE SOUTHEAST CORNER OF SAID LOT 12; THENCE N84°53'00"W 641.49' TO A 1" FOUND IRON PIPE; THENCE S00°07'26"E 260.04'; THENCE N89°35'12"E 807.14' TO A 1" FOUND IRON PIPE; THENCE S00°27'02"E 67.15' TO A 1" FOUND IRON PIPE; THENCE WITH A CURVE TO THE RIGHT WITH AN ARC LENGTH OF 57.69', WITH A RADIUS OF 67.00', WITH A CHORD THAT BEARS S24°18'04"W, FOR A LENGTH OF 55.93', TO A 1" FOUND IRON PIPE; THENCE WITH A CURVE TO THE LEFT WITH AN ARC LENGTH OF 254.19', WITH A RADIUS OF 533.00', WITH A CHORD THAT BEARS S35°30'50"W, FOR A LENGTH OF 251.79', TO A 1" FOUND IRON PIPE; WHICH IS THE POINT OF BEGINNING, HAVING AN AREA OF 5.00 ACRES MORE OR LESS.
