

# Plat of Survey

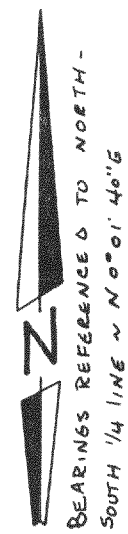
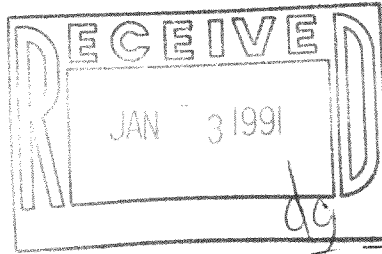

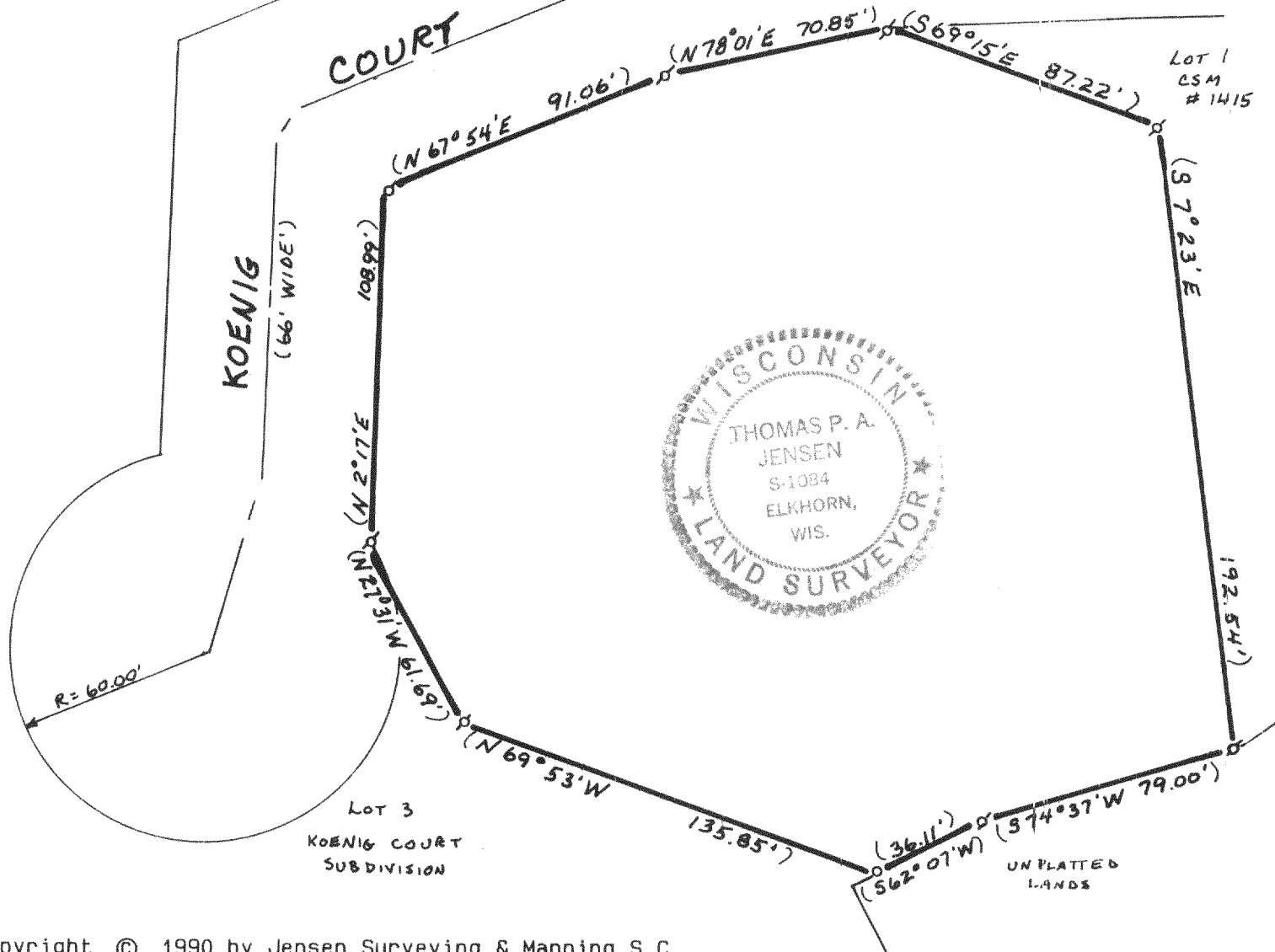
