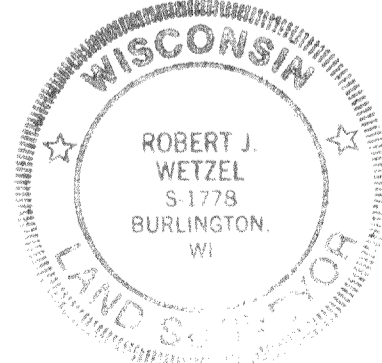

PARCEL I:

LOTS 4, 5 and 6, in MCGREGOR HIGHLANDS SUBDIVISION, located in Government Lot 2 in the Southeast 1/4 of the Northeast 1/4 of fractional Section 9, in Township 4 North, Range 18 East in the Town of East Troy.

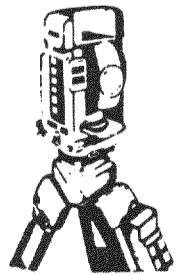
PARCEL II:

A parcel of land located in the Northeast 1/4 of Section 9, in Township 4 North, Range 18 East in the Town of East Troy, described as follows to-wit: Commencing at the East 1/4 section corner of said Section 9; thence West along the East-West 1/4 section line of said Section 9, 262 feet to the centerline of the Town Road; thence North 09° 59' West along the center line of said road 903 feet to the place of beginning; thence West 150.40 feet to the shore of Beulah Lake; thence Northwesterly and Northerly along the shore 232 feet to a point; thence East 221.30 feet to the centerline of said road; thence South 09° 59' East along the centerline of said road 162.50 feet to the place of beginning.

PARCEL III:

Also a parcel of land known as the ISLAND that is described as follows to-wit: Commencing at the above mentioned 1/4 Section corner; thence West 262 feet; thence North 09° 59' West 903 feet; thence West 150.40 feet to the shore of Beulah Lake; thence Northwesterly along the shore 52.5 feet; thence South 53° 52' West across the water of Lake Beulah 18.82 feet to a point on the shore of the Island to be described; thence Southwesterly along the shore 63.6 feet to a point that is located South 40° 50' West 51.45 feet from the place of beginning; thence Northwesterly along the shore 88.1 feet to a point that is located North 11° 44' West 84.62 feet from the last mentioned point; thence Southeasterly along the shore 68.4 feet to the place of beginning.

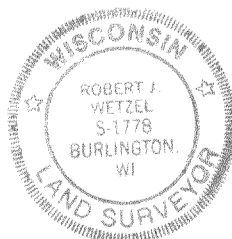
