Established all quarter-quarter corners upon the section boundary at proportional distances between known section and quarter section corners, according to the original field-notes of the Government survey.

Established the most complete and important historical record known of the original field notes of the Government survey.

being in the Township of La Grange, Walworth County, Wisconsin, described as follows to wit:-

Beginning at an iron stake, on the Easterly shore of Pleasant Lake, That is $525^{\circ}-15' W$ 60 feet from an iron stake, at the point where the north line of said section 25 intersects the said lake shore, and the said stake being witnessed by, a cotton wood tree southerly 15.5 feet, and an oak tree, Easterly, 17 feet; Thence $578^{\circ}-00' E$ 105 feet, to a stake; Thence $543^{\circ}-30' W$ 90 feet to a stake; Thence $N 63^{\circ}-00' W$ 73.5 feet to a stake on the shore of said lake, Thence ~~Thence~~ $N 25^{\circ}-15' E$ beating along the said shore 60 feet to the place of beginning, excepting and reserving, for a right of way to be used in common with others, a strip of land, 10 feet in width off of the Southeastly side of the above described piece.

That certain piece or parcel of land lying and being in the northwest quarter of Section no. 28, T2N, R16E, being the Town of Delavan, Walworth County, Wisconsin, described as follows to wit: Beginning at a point $1\frac{1}{2}$ rods south and 7 rods $5\frac{1}{2}$ ft. West of the Northeast corner of the said quarter section, being also the center of the road; thence south on a line parallel with the East line of said q. section 466.09 feet to an iron stake; thence Westerly 375.7 feet to a stake; thence north parallel with the East line of said quarter section 461.39 feet to a point $1\frac{1}{2}$ rods South of the North line of the said quarter section, being the center of the road; thence East being along the center of said road 375.7 feet to the place of beginning containing four (4) acres of land.
